BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18 MARYLAND, That the Laws of Maryland read as follows: 19 **Article - Courts and Judicial Proceedings** 20 12-701. 21 An appeal from an orphans' court or a circuit court stays all (a) (1) 22 proceedings in the orphans' court concerning the issue appealed. 23 An appeal from an orphans' court or a circuit court does not stay any 24 proceedings in the orphans' court that do not concern the issue appealed, if the 25 orphans' court can provide for conforming to the decision of the appellate court.
