- 3 FOR the purpose of adopting the 2002 Edition of the Annotated Code of Maryland as
- 4 published by the editorial staff of West, Eagan, Minnesota (West Code), and all
- 5 replacement volumes and supplements to the West Code; providing that the
- West Code and all replacement volumes and supplements to the West Code are
- 7 evidence of the Public General Laws of Maryland and shall be considered as
- 8 evidence of the law in all courts of the State and by all public offices and officers
- 9 of the State and its political subdivisions; and generally relating to the adoption
- of the West Code as evidence of the law in Maryland.

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

- 20 (a) (1) The 1957 Edition of the Annotated Code of Maryland, prepared and
- 21 published by the Editorial Staff of The Michie Company, Charlottesville, Virginia, is
- 22 adopted and made evidence of the Public General Laws of the State of Maryland as
- 23 contained in the Code of Public General Laws of Maryland of 1888, as amended,
- 24 modified and changed from time to time, through and including the regular session of
- 25 the General Assembly of Maryland held in 1957. It shall be considered as the evidence
- 26 of the law in all courts of the State and by all public offices and officers of the State
- 27 and its political subdivisions.
- 28 [(b)] (2) A replacement volume to the Annotated Code of the Public General
- 29 Laws of Maryland (1957 Edition), prepared and published by the Editorial Staff of

- 2 Public General Laws in the volume at the time of publication. It shall be considered as
- 3 evidence of the law in all courts of the State and by all public offices and officers of the

- 5 [(c)] (3) Any pocket or other supplement to a volume of the Annotated Code of
- 6 the Public General Laws of Maryland (1957 Edition or subsequent replacement
- 7 volume), prepared and published by the Editorial Staff of The Michie Company,
- 8 Charlottesville, Virginia, is adopted and made evidence of changes in the Public
- 9 General Laws which are supplementary or in addition to the laws in the main
- 10 volume. It shall be considered as evidence of the law in all the courts of the State and
- 11 by all public offices and officers of the State and its political subdivisions.
- 12 (B) (1) THE 2002 EDITION OF WEST'S ANNOTATED CODE OF MARYLAND,

- 25 CONSIDERED AS EVIDENCE OF THE LAW IN ALL THE COURTS OF THE STATE AND BY

- 28 (3) ANY POCKET OR OTHER SUPPLEMENT TO A VOLUME OF WEST'S
- 29 ANNOTATED CODE OF MARYLAND (2002 EDITION OR SUBSEQUENT REPLACEMENT
- 30 VOLUME), PREPARED AND PUBLISHED BY THE EDITORIAL STAFF OF WEST, EAGAN,
- 31 MINNESOTA, IS ADOPTED AND MADE EVIDENCE OF CHANGES IN THE PUBLIC
- 32 GENERAL LAWS WHICH ARE SUPPLEMENTARY OR IN ADDITION TO THE LAWS IN THE
- 33 MAIN VOLUME. IT SHALL BE CONSIDERED AS EVIDENCE OF THE LAW IN ALL THE
- 34 COURTS OF THE STATE AND BY ALL PUBLIC OFFICES AND OFFICERS OF THE STATE
- 35 AND ITS POLITICAL SUBDIVISIONS.
- 36 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 37 October 1, 2003.
