13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

17 (RR) (1) IN THIS SUBSECTION, "GOVERNMENT ORGANIZATION" INCLUDES:

18 (I) A COUNTY;

19 (II) A BOARD OF EDUCATION;

20 (III) A MUNICIPAL CORPORATION; OR

1 (IV) A GOVERNMENT COOPERATIVE PURCHASING ORGANIZATION.
