Procurement - Percentage Price Preference for Recycled Materials -Chicken Litter

4 FOR the purpose of establishing a certain percentage price preference for items made

- 5 with processed and pasteurized chicken litter; altering the definition of a certain
- 6 term; providing for a certain effective date; and generally relating to a
- 7 percentage price preference for chicken litter.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 14 MARYLAND, That the Laws of Maryland read as follows:
- 15 Article State Finance and Procurement

16 14-405.

17 (a) (1) In this section the following words have the meanings indicated.

HOUSE BILL 325

1 (2) (i) "Recycled materials" means material recovered from or 2 otherwise destined for the waste stream.

3 (ii) "Recycled materials" includes post-consumer material,
4 industrial scrap material, compost, PROCESSED AND PASTEURIZED CHICKEN LITTER,
5 and obsolete inventories.

6 (3) "Percentage price preference" means the percent by which a 7 responsive bid from a responsible bidder whose product contains recycled materials 8 may exceed the lowest responsive bid submitted by a responsible bidder whose 9 products do not contain recycled materials.

10 (b) No later than January 1, 1994, the Board shall adopt regulations that 11 require the Secretary of General Services, the Secretary of Transportation, and the 12 Chancellor of the University System of Maryland to establish a percentage price 13 preference, not to exceed 5%, for the purchase of products made from recycled 14 materials.

15 (c) A percentage price preference under this section may not be used in 16 conjunction with any other percentage price preference established under this title.

17 (d) (1) To encourage the maximum purchase of commodities utilizing

18 recycled materials, the Department of General Services, in consultation with the

19 Department of the Environment, the University of Maryland, the Maryland20 Environmental Service, the Department of Transportation, the Department of

21 Natural Resources, the Department of Health and Mental Hygiene, and as necessary

22 with representatives of the recycling industry and environmental organizations, shall

23 establish a list of acceptable products which contain recycled materials.

24 (2) The list shall be published for use by State agencies at least twice 25 each year.

26 (e) By January 1, 1991, each State unit shall review the procurement 27 specifications currently used by the unit and, to the extent practicable, require the 28 use of a percentage price preference in their purchase of supplies and commodities

29 containing recycled materials.

30 (f) (1) Except as provided in paragraph (2) of this subsection, this section is 31 broadly applicable to all procurements by the State if the quality of the product is 32 consistent with the requirements of the bid specifications.

33 (2) Only to the extent necessary to prevent the denial of federal moneys
34 or eliminate the inconsistency with federal law, this section does not apply to a

35 procurement by the State if the procurement officer determines that compliance with

36 this section would:

(i) cause denial of federal moneys; or

(ii) be inconsistent with the requirements of federal law.
