1 **Article - Criminal Procedure** 2 6-219. 3 (c) If the court places on probation a defendant who has been convicted (1) 4 of a violation of [§ 21-902(a) or (b)] § 21-902 of the Transportation Article OR § 2-503, 5 § 2-504, § 2-505, § 2-506, OR § 3-211 OF THE CRIMINAL LAW ARTICLE, the court shall 6 require as a condition that the defendant participate in an alcohol OR DRUG 7 treatment or education program approved by the Department of Health and Mental 8 Hygiene, unless the court finds and states on the record that the interests of the 9 defendant and the public do not require the imposition of this condition. 10 6-220. 11 When the crime for which the judgment is being stayed is for a 12 violation of § 21-902 of the Transportation Article OR § 2-503, § 2-504, § 2-505, § 2-506, 13 OR § 3-211 OF THE CRIMINAL LAW ARTICLE, the court shall impose a period of 14 probation and, as a condition of the probation: 15 shall require the defendant to participate in an alcohol OR 16 DRUG treatment or education program approved by the Department of Health and 17 Mental Hygiene, unless the court finds and states on the record that the interests of 18 the defendant and the public do not require the imposition of this condition; and 19 may prohibit the defendant from operating a motor vehicle (ii) 20 unless the motor vehicle is equipped with an ignition interlock system under § 27-107
