15 16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

19 20	(c) (1) Except as provided in paragraph (2)(ii) of this subsection, in Baltimore County, members of the party central committees may not run at large.
21	(2) The Republican Party Central Committee shall consist of:
22 23	(i) four members elected from each councilmanic district in the county; and
24	(ii) a chairman elected from the county at large

## **HOUSE BILL 350**

- 1 (3)[The] FOR THE Baltimore County Democratic Party Central 2 Committee [shall consist of five members elected from each councilmanic district in 3 Baltimore County]: 4 TWENTY-FIVE MEMBERS, FIVE FROM EACH DISTRICT, SHALL (I) 5 BE ELECTED FROM LEGISLATIVE DISTRICTS 6, 8, 10, 11, AND 42, EACH DISTRICT BEING 6 LOCATED WHOLLY WITHIN BALTIMORE COUNTY; TWO MEMBERS SHALL BE ELECTED FROM LEGISLATIVE 7 (II)8 DISTRICT 5 LOCATED WHOLLY WITHIN BALTIMORE COUNTY: 9 FOUR MEMBERS SHALL BE ELECTED FROM THAT PART OF (III)10 LEGISLATIVE DISTRICT 7 THAT IS LOCATED IN BALTIMORE COUNTY; AND 11 (IV) THREE MEMBERS SHALL BE ELECTED FROM THAT PART OF 12 LEGISLATIVE DISTRICT 12 THAT IS LOCATED IN BALTIMORE COUNTY. 13 Only individuals affiliated with the Democratic Party and who are 14 registered to vote in Baltimore County may vote for the election of members to the 15 Baltimore County Democratic Party Central Committee under this section. THE NUMBER OF DEMOCRATIC PARTY CENTRAL COMMITTEE 16 17 MEMBERS TO BE ELECTED FROM EACH LEGISLATIVE DISTRICT, OR PORTION OF 18 LEGISLATIVE DISTRICT, IN BALTIMORE COUNTY SHALL BE DETERMINED UPON 19 COMPLETION OF EACH LEGISLATIVE DISTRICTING. SECTION 2. AND BE IT FURTHER ENACTED, That the next election for the 20
- 21 Baltimore County Democratic Party Central Committee members will be in 2006 on
- 22 the same day the primary election for the Governor is held. Members elected at this
- 23 time will serve 4-year terms. The members of the Baltimore County Democratic
- 24 Party Central Committee who were elected in 2002 shall complete their term that
- 25 expires in 2006.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 26
- 27 October 1, 2003.
