- 3 FOR the purpose of establishing the Early Childhood Mental Health Services Pilot
- 4 Program; requiring the pilot program to provide mental health screening and
- 5 consultation for certain children; specifying that the pilot program may include
- 6 formal training for child care providers, therapeutic nursery programs, family
- 7 support initiatives, crisis intervention services, certain recruiting programs, and
- 8 certain mental health consultation; requiring certain agencies to submit a
- 9 certain report; making this Act subject to a certain contingency; providing for
- the termination of this Act; and generally relating to the Early Childhood

- 19 WHEREAS, The General Assembly has identified as a priority the development
- 20 of strategies to prepare children to enter school ready to learn; and
- 21 WHEREAS, Recent neurological research strongly supports the proposition that
- 22 young children's social and emotional development before they enter school is an
- 23 essential foundation to young children's learning skills and later school success; and
- 24 WHEREAS, The National Academy of Sciences has concluded that enhancement
- 25 of social and emotional development is as important in early childhood as
- 26 enhancement of linguistic and cognitive competence and has recommended that
- 27 resources similar to those focused on literacy and numerical skills should be devoted
- 28 to promoting young children's social and emotional development; and

- 6 ON OR BEFORE DECEMBER 31, 2005, THE CHILD CARE ADMINISTRATION, IN
- 7 COLLABORATION WITH THE MENTAL HYGIENE ADMINISTRATION, THE STATE
- 8 DEPARTMENT OF EDUCATION, AND THE GOVERNOR'S OFFICE OF CHILDREN, YOUTH,
- 9 AND FAMILIES, SHALL SUBMIT A REPORT TO THE GOVERNOR AND, IN ACCORDANCE
- 10 WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY THAT
- 11 EVALUATES THE PILOT PROGRAM ESTABLISHED UNDER THIS SUBTITLE AND
- 12 COMPARABLE PROGRAMS AS APPLICABLE.
- 13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is contingent
- 14 on the receipt of sufficient federal funds or funds from any other private or public
- 15 source, including the continued receipt of funds from sources that funded the pilot
- 16 program in Baltimore City and the Eastern Shore prior to July 1, 2003. If the Child
- 17 Care Administration receives the funding specified in this section, it shall forward a
- 18 notice of the receipt of the funding within 5 days of receipt to the Department of
- 19 Legislative Services, 90 State Circle, Annapolis, Maryland 21401-1991.
- 20 SECTION 3. AND BE IT FURTHER ENACTED, That, subject to Section 2 of
- 21 this Act, this Act shall take effect October 1, 2003. It shall remain effective for a
- 22 period of 4 years and 3 months and, at the end of December 31, 2007, with no further
- 23 action required by the General Assembly, this Act shall be abrogated and of no further
- 24 force and effect.
