2 Health Insurance - Kidney Dialysis Services - Coinsurance Payments

- 3 FOR the purpose of limiting the coinsurance payment amount that a health insurer,
- 4 nonprofit health service plan, or health maintenance organization may charge
- 5 or collect for kidney dialysis services provided in a kidney dialysis center to an
- 6 individual with chronic kidney disease; defining a certain term; providing for

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:

- 23 (ZZ) THE PROVISIONS OF § 15-118.1 OF THE INSURANCE ARTICLE APPLY TO
- 24 HEALTH MAINTENANCE ORGANIZATIONS.

- 3 (A) IN THIS SECTION, "KIDNEY DIALYSIS CENTER" HAS THE MEANING STATED 4 IN § 19-3B-01(H) OF THE HEALTH GENERAL ARTICLE.
- 5 (B) THIS SECTION APPLIES TO:
- 6 (1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE
- 7 HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS ON AN
- 8 EXPENSE-INCURRED BASIS UNDER HEALTH INSURANCE POLICIES OR CONTRACTS
- 9 THAT ARE ISSUED OR DELIVERED IN THE STATE; AND
- 10 (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE HOSPITAL,
- 11 MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS UNDER CONTRACTS
- 12 THAT ARE ISSUED OR DELIVERED IN THE STATE.
- 13 (C) FOR KIDNEY DIALYSIS SERVICES PROVIDED IN A KIDNEY DIALYSIS
- 14 CENTER TO AN INDIVIDUAL WITH CHRONIC KIDNEY DISEASE, AN ENTITY SUBJECT
- 15 TO THIS SECTION MAY ONLY CHARGE OR COLLECT FROM AN INSURED A SINGLE
- 16 COINSURANCE PAYMENT AMOUNT IN A 3-MONTH PERIOD.
- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all
- 18 policies, contracts, and health benefit plans issued, delivered, or renewed in the State
- 19 on or after October 1, 2003. Any policy, contract, or health benefit plan in effect before
- 20 October 1, 2003 shall comply with the provisions of this Act no later than October 1,
- 21 2004.
- 22 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 23 October 1, 2003.
