A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County - Special Class C Beer, Wine and Liquor License -**  
3 **Fees**  
4 **PG 304-03**

5 FOR the purpose of altering the license fee for a special Class C beer, wine and liquor  
6 license in Prince George's County; repealing an obsolete provision establishing a  
7 special Class C beer, wine and liquor license fee for certain casino or gambling  
8 events; and generally relating to special Class C beer, wine and liquor licenses in  
9 Prince George's County.

10 BY repealing and reenacting, without amendments,  
11 Article 2B - Alcoholic Beverages  
12 Section 7-101(a)(1) and (d)(1)  
13 Annotated Code of Maryland  
14 (2001 Replacement Volume and 2002 Supplement)

15 BY repealing and reenacting, with amendments,  
16 Article 2B - Alcoholic Beverages  
17 Section 7-101(d)(11)  
18 Annotated Code of Maryland  
19 (2001 Replacement Volume and 2002 Supplement)

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article 2B - Alcoholic Beverages**

23 7-101.

24 (a) (1) On approval by the board of license commissioners for that  
25 jurisdiction, if any, of a proper application, made on forms prescribed by the State  
26 Comptroller, signed and sworn to, the license issuing authority may grant the types of  
27 special licenses for the periods and at the fees specified in this section.

1 (d) (1) (i) A special Class C beer, wine and liquor license entitles the  
2 holder to exercise any of the privileges conferred by this class of license for the use of  
3 any person holding a bona fide entertainment conducted by a club, society, or  
4 association at the place described for a period not exceeding seven consecutive days,  
5 upon the payment of a fee of \$15 per day.

6 (ii) The provisions of § 11-517 of this article do not apply to holders  
7 of this license. Alcoholic beverages sold under this special license shall be purchased  
8 by such special license holder from retail dealers.

9 (11) In Prince George's County:

10 (i) [Except as provided in item (ii) of this paragraph, the] THE fee  
11 is [~~\$50~~] \$150 per day; AND

12 (ii) [For a club, society, or association holding a casino or gambling  
13 event, the fee is \$150 per day, which shall be paid by the club, society, or association  
14 and shall be considered as part of the club's, society's, or association's special license  
15 fee; and

16 (iii) The Board of License Commissioners may deny an application  
17 for this license if it is determined that the applicant does not qualify under the  
18 provisions of this article.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 October 1, 2003.
