1 AN ACT concerning

2 **Prince George's County - Alcoholic Beverages Districts - Conformity to**
3 **Legislative Districting Plan**
4 **PG 309-03**

5 FOR the purpose of altering certain alcoholic beverages districts in Prince George's
6 County so that they are coterminous with certain legislative districts or parts of
7 districts contained in the State legislative districting plan ordered by the Court
8 of Appeals of Maryland; describing the constituent parts of certain alcoholic
9 beverages districts; prohibiting with a certain exception the Board of License
10 Commissioners of Prince George's County from issuing or transferring certain
11 alcoholic beverages licenses within certain alcoholic beverages districts under
12 certain circumstances; and generally relating to alcoholic beverages districts in
13 Prince George's County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article 2B - Alcoholic Beverages**

5 [(l) (1) The Board of License Commissioners may not issue any new beer,
6 wine or liquor licenses that have an off-sale privilege within, or transfer any
7 additional beer, wine or liquor licenses that have an off-sale privilege into the
8 boundaries of the 13th, 21st, 22nd, 23rd, 24th, 25th, 26th, or 27th alcoholic beverages
9 district:

10 (i) The 13th alcoholic beverages district shall at all times be
11 coterminous with the Prince George's County portion of the 13th legislative district,
12 as determined by the Prince George's County Board of Supervisors of Elections. As of
13 April 7, 1994, the Prince George's County portion of the 13th alcoholic beverages
14 district consisted of:

15 1. Prince George's County election district 10, precincts 2
16 through 4;

17 2. That part of Prince George's County election district 10,
18 precinct 1 that consists of census tract 8002.04, blocks 109 through 113, 119, 121
19 through 123, and 128, being generally north of Engleman Drive and Briarwood Drive;
20 and

21 3. That part of Prince George's County election district 10,
22 precinct 9 that consists of the following census tracts and blocks:

23 A. Census tract 8001.03, blocks 210, 213, 214, 216, 221, 222A,
24 222B, and 226; and

25 B. Census tract 8002.04, blocks 101, 102, 103A through 103C,
26 104A, 105, 114, 115, 116A through 116C, 117, 118A, and 118B, being that area
27 generally north of Old Stagecoach Road.

28 (ii) The 21st alcoholic beverages district at all times shall be
29 coterminous with the 21st legislative district of Prince George's County, as
30 determined by the Prince George's County Board of Supervisors of Elections. As of
31 April 7, 1994, the 21st alcoholic beverages district consisted of:

32 1. Election district 1;

33 2. Election district 10, precincts 1, 5, 6, 7, 8, and 11;

34 3. Election district 17, precincts 4, 10, 11, 13, 14, 15, and 16;
35 and

36 4. Election district 21, precincts 1, 2, 4, 5, 10, 14, 15, and 17.

1 (iii) The 22nd alcoholic beverages district at all times shall be
 2 coterminous with the 22nd legislative district of Prince George's County, as
 3 determined by the Prince George's County Board of Supervisors of Elections. As of
 4 April 7, 1994, the 22nd alcoholic beverages district consisted of:

- 5 1. Election district 2, precincts 3, 4, 5, 6, 8, 9, and 10;
- 6 2. Election district 16;
- 7 3. Election district 17, precincts 6, 7, 9, and 12;
- 8 4. Election district 19;
- 9 5. Election district 20, precincts 1, 2, 3, 6, 7, and 11; and
- 10 6. Election district 21, precincts 7, 9, and 12.

11 (iv) The 23rd alcoholic beverages district at all times shall be
 12 coterminous with the 23rd legislative district of Prince George's County, as
 13 determined by the Prince George's County Board of Supervisors of Elections. As of
 14 April 7, 1994, the alcoholic beverages district consisted of:

- 15 1. Prince George's County election district 14;
- 16 2. Prince George's County election district 3, precinct 2;
- 17 3. Prince George's County election district 7, precincts 1
 18 through 8;
- 19 4. Prince George's County election district 20, precincts 5
 20 and 9;
- 21 5. Prince George's County election district 21, precincts 3, 6,
 22 8, 11, 13, and 16;
- 23 6. That part of Prince George's County election district 7,
 24 precinct 9 that consists of the following census tracts and blocks:
 - 25 A. Census tract 8005.08, block 210;
 - 26 B. Census tract 8005.09, blocks 201 through 210 and 213
 27 through 235; and
 - 28 C. Census tract 8035.05, blocks 103 and 105;
- 29 7. That part of Prince George's County election district 10,
 30 precinct 10 that consists of the following census tracts and blocks:
 - 31 A. Census tract 8002.06, blocks 101A, 101B, 101C, 102, 103,
 32 105, 108, 109, and 111; and

1 B. Census tract 8004.06, blocks 201 and 215; and

2 8. That part of Prince George's County election district 21,
3 precinct 9 that consists of census tract 8067.07, blocks 101, 103A, 106, and 107.

4 (v) The 24th alcoholic beverages district at all times shall be
5 coterminous with the 24th legislative district of Prince George's County, as
6 determined by the Prince George's County Board of Supervisors of Elections. As of
7 April 7, 1994, the alcoholic beverages district consisted of:

8 1. Election district 2, precincts 1, 2, and 7;

9 2. Election district 6, precinct 3;

10 3. Election district 13, precincts 1, 2, 3, 5, 7, 8, 14, 15, and 16;

11 4. Election district 17, precincts 1, 2, 3, 5, and 8;

12 5. Election district 18, precincts 1, 2, 3, 4, 5, 7, 8, and 9; and

13 6. Election district 20, precincts 4 and 8.

14 (vi) The 25th alcoholic beverages district at all times shall be
15 coterminous with the 25th legislative district of Prince George's County, as
16 determined by the Prince George's County Board of Supervisors of Elections. As of
17 April 7, 1994, the 25th alcoholic beverages district consisted of:

18 1. Election district 6, precincts 1, 4, 5, 6, 7, 9, 10, 11, 12, 15,
19 16, 18, 19, 20, 21, and 22;

20 2. Election district 9, precincts 3 and 10;

21 3. Election district 13, precincts 4, 6, 9, 10, 11, 12, and 13;

22 and

23 4. Election district 18, precinct 6.

24 (vii) The 26th alcoholic beverages district at all times shall be
25 coterminous with the 26th legislative district of Prince George's County, as
26 determined by the Prince George's County Board of Supervisors of Elections. As of
27 April 7, 1994, the 26th alcoholic beverages district consisted of:

28 1. Election district 5, precincts 2, 5, and 6;

29 2. Election district 6, precincts 2, 8, 13, 14, and 17;

30 3. Election district 9, precincts 2 and 5; and

31 4. Election district 12, precincts 1 through 14.

1 (viii) The 27th alcoholic beverages district at all times shall be
 2 coterminous with the 27th legislative district of Prince George's County, as
 3 determined by the Prince George's County Board of Supervisors of Elections. As of
 4 April 7, 1994, the 27th alcoholic beverages district consisted of:

- 5 1. Election district 3, precincts 1 and 3;
- 6 2. Election district 4, precinct 1;
- 7 3. Election district 5, precincts 1, 3, and 4;
- 8 4. Election district 8, precinct 1;
- 9 5. Election district 9, precincts 1, 4, 6, 7, 8, and 9;
- 10 6. Election district 11, precincts 1 and 2; and
- 11 7. Election district 15, precincts 1 through 3.

12 (2) The Prince George's County Board of License Commissioners may
 13 approve the issuance or transfer of a license into the boundaries of the 13th (that
 14 portion located within the county), 21st, 22nd, 23rd, 24th, 25th, 26th, or 27th
 15 alcoholic beverages district provided any off-sale privileges of the license are
 16 permanently waived as long as the license remains within the boundaries of the
 17 district.]

18 (L) (1) THE BOARD OF LICENSE COMMISSIONERS MAY NOT ISSUE ANY NEW
 19 BEER, WINE OR LIQUOR LICENSES THAT HAVE AN OFF-SALE PRIVILEGE WITHIN, OR
 20 TRANSFER ANY ADDITIONAL BEER, WINE OR LIQUOR LICENSES THAT HAVE AN
 21 OFF-SALE PRIVILEGE INTO THE BOUNDARIES OF THE 21ST (THAT PART LOCATED
 22 WITHIN THE COUNTY), 22ND, 23RD, 24TH, 25TH, 26TH, 27TH (THAT PART LOCATED
 23 WITHIN THE COUNTY), OR 47TH ALCOHOLIC BEVERAGES DISTRICT AS FOLLOWS:

9 (2) THE PRINCE GEORGE'S COUNTY BOARD OF LICENSE
10 COMMISSIONERS MAY APPROVE THE ISSUANCE OR TRANSFER OF A LICENSE INTO
11 THE BOUNDARIES OF THE 21ST (THAT PART LOCATED WITHIN THE COUNTY), 22ND,
12 23RD, 24TH, 25TH, 26TH, 27TH (THAT PART LOCATED WITHIN THE COUNTY), OR 47TH
13 ALCOHOLIC BEVERAGES DISTRICT PROVIDED ANY OFF-SALE PRIVILEGES OF THE
14 LICENSE ARE PERMANENTLY WAIVED AS LONG AS THE LICENSE REMAINS WITHIN
15 THE BOUNDARIES OF THE DISTRICT.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 June 1, 2003.
