## 2 Baltimore City - Marvellous Works Outreach Center Loan of 2001

- 3 FOR the purpose of altering the date by which the grantee is required to provide and
- 4 expend a matching fund, from June 1, 2003 to June 1, 2005 pursuant to Chapter
- 5 698 of the Acts of the General Assembly of 2001, Baltimore City Marvellous
- Works Outreach Center Loan of 2001; and generally relating to the Baltimore
- 7 City Marvellous Works Outreach Center Loan of 2001.

- 9 Chapter 698 of the Acts of the General Assembly of 2001
- 10 Section 1(5)
- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 12 MARYLAND, That the Laws of Maryland read as follows:

## 13 Chapter 698 of the Acts of 2001

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That:
- 16 (5) Prior to the payment of any funds under the provisions of this Act for the
- 17 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 18 matching fund. No part of the grantee's matching fund may be provided, either
- 19 directly or indirectly, from funds of the State, whether appropriated or
- 20 unappropriated. The fund may consist of real property, in kind contributions, and
- 21 funds expended prior to the effective date of this Act. In case of any dispute as to the
- 22 amount of the matching fund or what money or assets may qualify as matching funds,
- 23 the Board of Public Works shall determine the matter and the Board's decision is
- 24 final. The grantee has until June 1, [2003] 2005, to present evidence satisfactory to
- 25 the Board of Public Works that a matching fund will be provided. If satisfactory
- 26 evidence is presented, the Board shall certify this fact and the amount of the
- 27 matching fund to the State Treasurer, and the proceeds of the loan equal to the
- 28 amount of the matching fund shall be expended for the purposes provided in this Act.
- 29 Any amount of the loan in excess of the amount of the matching fund certified by the
- 30 Board of Public Works shall be canceled and be of no further effect.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 June 1, 2003.
