18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

19 MARYLAND, That the Laws of Maryland read as follows:

Article - Health - General

22 (ZZ) THE REQUIREMENTS OF § 15-841 OF THE INSURANCE ARTICLE APPLY TO 23 HEALTH MAINTENANCE ORGANIZATIONS.

3 (A) THIS SECTION APPLIES TO:

4 (1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE
5 HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS ON AN
6 EXPENSE-INCURRED BASIS UNDER HEALTH INSURANCE POLICIES OR CONTRACTS
7 THAT ARE ISSUED OR DELIVERED IN THE STATE; AND

8 (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE HOSPITAL,
9 MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS UNDER CONTRACTS
10 THAT ARE ISSUED OR DELIVERED IN THE STATE.

11 (B) AN ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE COVERAGE FOR
12 THE EXPENSES INCURRED IN CONDUCTING A CA-125 SERUM TUMOR MARKER TEST
13 FOR THE PURPOSE OF SCREENING FOR OVARIAN CANCER.

14 (C) AN ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE THE BENEFITS
15 REQUIRED UNDER THIS SECTION TO THE SAME EXTENT AS FOR ANY OTHER
16 MEDICAL CONDITION UNDER THE ENROLLEE'S OR INSURED'S CONTRACT OR POLICY
17 WITH THE ENTITY.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to
all policies, contracts, and health benefit plans issued, delivered, or renewed in the
State on or after October 1, 2003. Any policy, contract, or health benefit plan in effect
before October 1, 2003, shall comply with the provisions of this Act no later than
October 1, 2004.

23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take 24 effect October 1, 2003.
