BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows: 18 **Article - Education** 19 7-420. IN THIS SECTION, "POLE VAULTING" MEANS AN ACTIVITY THAT IS 20 (A) 21 ORGANIZED FOR INTRAMURAL, INTERSCHOLASTIC, RECREATIONAL, OR 22 COMPETITIVE PURPOSES FOR CHILDREN AGES 5 THROUGH 18 YEARS OLD, 23 INCLUSIVE, THAT INVOLVES JUMPING OVER A HIGH CROSSBAR WITH THE AID OF A 24 LONG POLE AND IS SPONSORED BY: 25 (1) A PUBLIC SCHOOL;

A NONPUBLIC ELEMENTARY OR SECONDARY SCHOOL;

ANY UNIT OF LOCAL GOVERNMENT; OR

- 1 (4) ANY PRIVATE ORGANIZATION SPONSORING A POLE VAULTING 2 COMPETITION IN THE STATE.
- 3 (B) THE SPONSORING ENTITY OF A POLE VAULTING COMPETITION OR
- 4 PRACTICE SESSION SHALL RECOMMEND THAT EACH CHILD PARTICIPATING IN A
- 5 POLE VAULTING EVENT WEAR A PROPER FITTING HELMET DURING COMPETITION
- 6 AND PRACTICE SESSIONS.
- 7 (C) (1) EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, A CHILD
- 8 MAY PARTICIPATE IN A POLE VAULTING COMPETITION OR PRACTICE SESSION WHILE
- 9 NOT WEARING A HELMET IF THE PARENT OR GUARDIAN OF THAT CHILD SIGNS A
- 10 WRITTEN WAIVER OF LIABILITY FOR ANY INJURIES RESULTING FROM
- 11 PARTICIPATION IN A POLE VAULTING EVENT.
- 12 (2) THE WAIVER UNDER THIS SECTION SHALL BE MADE ON A FORM
- 13 APPROVED BY THE SPONSORING ENTITY OF THE POLE VAULTING COMPETITION OR
- 14 PRACTICE SESSIONS.
- 15 (D) NOTWITHSTANDING THE PROVISIONS OF THIS SUBSECTION, IF THE
- 16 RULES OF THE SPONSORING ENTITY OF A POLE VAULTING COMPETITION REQUIRE A
- 17 PARTICIPATING CHILD TO WEAR A HELMET TO PARTICIPATE IN A POLE VAULTING
- 18 COMPETITION. THE CHILD SHALL WEAR A HELMET IN ACCORDANCE WITH THE
- 19 RULES OF THE SPONSORING ENTITY.
- 20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 21 July 1, 2003.
