A BILL ENTITLED

1 AN ACT concerning

2 **Higher Education - Educational Excellence Awards - Funding**

3 FOR the purpose of requiring a minimum amount of funding appropriated annually
4 for Educational Assistance Grants to be allocated to institutions of higher
5 education in the State to fund Educational Excellence Awards; and generally
6 relating to funding for Educational Excellence Awards.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article - Education**

15 18-307.

16 (a) Except as provided in subsection (d) of this section, the Office shall compile
17 and certify lists for the entire State that rank applicants by financial need.

18 (b) All funds for annual initial grants shall be awarded from the statewide list
19 on the basis of greatest financial need.

20 (c) On or before May 1 of each year, the Office shall send each Senator and
21 each Delegate a list of individuals in each legislative district to whom Educational
22 Excellence Awards are awarded.

23 (d) (1) (I) [If State funds are available for this purpose, institutions]
24 INSTITUTIONS of higher education in the State may provide Educational Excellence
25 Awards to students who otherwise meet the requirements for receiving an
26 Educational Excellence Award but who apply after the March 1 deadline or have
27 other extenuating circumstances.

1 (II) AT LEAST \$3 MILLION OF THE TOTAL FUNDS APPROPRIATED
2 FOR EDUCATIONAL ASSISTANCE GRANTS SHALL BE ALLOCATED TO INSTITUTIONS
3 OF HIGHER EDUCATION IN THE STATE TO PROVIDE EDUCATIONAL EXCELLENCE
4 AWARDS IN ACCORDANCE WITH THIS SUBSECTION.

5 (2) The Commission shall:

6 (i) Establish guidelines for the awarding of Educational Excellence
7 Awards by the institutions of higher education to the students; and

8 (ii) Adopt regulations necessary for the implementation of this
9 subsection.

10 (3) (i) The Commission shall allocate available funds to institutions of
11 higher education based on the proportion of State residents enrolled at each
12 institution who receive federal Pell Grants.

13 (ii) An institution of higher education that receives funds under
14 this paragraph shall provide the Commission with an annual audit describing the
15 disposition of the funds.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2003.
