7 (5) Purchases based on federal, state, county, or municipal contracts that 8 are established by a legal competitive process; AND

9 (6) PURCHASES OR CONTRACTS AS PROVIDED FOR IN SUBSECTION (B) 10 OF THIS SECTION.

(B) FOR PURCHASES OR CONTRACTS INVOLVING LESS THAN \$250,000 WHERE
THE COUNTY IS ACTING AS THE GENERAL CONTRACTOR, THE PURCHASE OR
CONTRACT MAY BE AWARDED AFTER THE COUNTY OBTAINS QUOTES FOR THE
PURCHASE OR CONTRACT FROM AT LEAST 3 VENDORS OR SUBCONTRACTORS.
