SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

(3) At the end of a term, a voting member continues to serve until a 12 successor is appointed and qualifies. 14 for the remainder of the term and until a successor is appointed and qualifies.

15 (5) A voting member may not serve more than two consecutive full 16 terms.
(6) To the extent practicable, the Governor and the Mayor shall fill any vacancy on the Board within 60 days of the date of the vacancy.
(7) THE GOVERNOR AND THE MAYOR SHALL APPOINT SEVEN MEMBERS OF THE BOARD AS PROVIDED IN SUBSECTION (C)(1) OF THIS SECTION ON OR BEFORE THE NOVEMBER 15, 2004 AND EVERY 4 YEARS THEREAFTER.
(k) On the joint approval of the Mayor of Baltimore City and the Governor, a member may be removed only for cause in accordance with § 3-108 of this subtitle.
(1) (1) [Each member of the Board serves without compensation] THE CHAIRMAN OF THE BOARD IS ENTITLED TO RECEIVE $\$ 10,000$ ANNUALLY AS COMPENSATION AND THE OTHER VOTING MEMBERS ARE EACH ENTITLED TO RECEIVE \$5,000 ANNUALLY AS COMPENSATION.
(2) VOTING MEMBERS ARE ENTITLED TO REIMBURSEMENT, AFTER SUBMITTING VOUCHERS, FOR TRAVEL AND OTHER EXPENSES.
(3) A STUDENT MEMBER MAY NOT RECEIVE COMPENSATION, BUT AFTER SUBMITTING EXPENSE VOUCHERS, MAY BE REIMBURSED FOR TRAVEL AND OTHER EXPENSES.
(m) [On appointment of the Board, the Governor and the Mayor shall jointly select one of the voting members to serve as the Chairman of the Board who shall serve through June 30, 1999] THE CHAIRMAN OF THE BOARD SHALL BE THE VOTING MEMBER ELECTED AT LARGE BY THE VOTERS OF BALTIMORE CITY.

1 (n) [Beginning on July 1, 1999 and every 2 years thereafter, from among its 2 voting members the Board shall elect a chairman.] THE TERMS OF THE ELECTED 3 VOTING MEMBERS ARE STAGGERED AS FOLLOWS:
