- 3 FOR the purpose of authorizing certain school teachers, administrators, and
- 4 librarians to read or post in any public school building certain patriotic
- 5 materials that may contain certain religious references, quotations, or
- 6 illustrations; prohibiting the censorship of certain materials based on religious
- 7 content in certain locations; and generally relating to the Expressions of
- 8 Patriotism Protection Act.

- 15 WHEREAS, The General Assembly finds that expressions of patriotism promote
- 16 liberty and religious freedom consistent with Article 36 and 37 of the Maryland
- 17 Declaration of Rights; and
- 18 WHEREAS, Public expressions of patriotism should be encouraged throughout
- 19 Maryland; now, therefore,
- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:

- 24 (a) This section is enacted so that the love of freedom and democracy, shown in
- 25 the devotion of all true and patriotic Americans to their flag and country, shall be
- 26 instilled in the hearts and minds of the youth of America.

- 1 (2) THERE SHALL BE NO CENSORSHIP OF THE MATERIALS RELATED TO
- 2 AMERICAN OR MARYLAND HISTORY, HERITAGE, OR CULTURE AS LISTED IN
- 3 PARAGRAPH (1) OF THIS SUBSECTION BASED ON RELIGIOUS CONTENT IN ANY
- 4 PUBLIC SCHOOL OR LIBRARY OF THIS STATE.
- 5 (F) Each county board may provide for any other patriotic exercises it
- 6 considers appropriate under the regulations and instruction that best meet the
- 7 requirements of the different grades in the schools.
- 8 [(f)] (G) Any individual who commits an act of disrespect, either by word or
- 9 action, is in violation of the intent of this section.
- 10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 11 July 1, 2003.
