2 Telephone Companies - Intracounty and Adjacent Local Calling

- 3 FOR the purpose of requiring the Public Service Commission to classify as toll-free
- 4 certain calls made within a county or within a certain distance from a county;
- 5 prohibiting a local exchange telephone service provider from separately billing
- 6 certain calls; providing for the application and construction of this Act; providing
- for a delayed effective date; and generally relating to local calling areas and

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

16 Article - Public Utility Companies

17 4-301.1.

- 18 (A) THIS SECTION APPLIES TO A PERSON WHO PROVIDES TELEPHONE
- 19 SERVICE IN THE STATE, INCLUDING A TELEPHONE COMPANY, UNLESS FEDERAL LAW
- 20 PROHIBITS THE PERSON FROM PROVIDING COUNTYWIDE SERVICE IN A PARTICULAR
- 21 COUNTY.
- 22 (B) (1) THE COMMISSION SHALL CLASSIFY AS TOLL-FREE ANY TELEPHONE
- 23 CALL MADE:
- 24 (I) BETWEEN ANY TWO POINTS WITHIN A SINGLE COUNTY; OR
- 25 (II) BETWEEN A POINT IN ONE COUNTY AND ANOTHER POINT
- 26 WITHIN 40 MILES OF THAT COUNTY.

- 1 (2) A LOCAL EXCHANGE TELEPHONE SERVICE PROVIDER MAY NOT BILL
- 2 ANY TELEPHONE CALL THAT IS TOLL-FREE UNDER PARAGRAPH (1) OF THIS
- 3 SUBSECTION SEPARATELY FROM THE MONTHLY LOCAL TELEPHONE SERVICE
- 4 CHARGE FOR THE LINE FROM WHICH THE CALL IS MADE.
- 5 (C) THIS SECTION MAY NOT BE CONSTRUED TO LIMIT, TO INCREASE RATES
- 6 FOR, OR OTHERWISE TO INTERFERE WITH TELEPHONE SERVICE PROVIDED TO
- 7 CUSTOMERS UNDER A FOREIGN EXCHANGE TELEPHONE LINE TARIFF OR PROGRAM.

- 9 January 1, 2004.
