CHAPTER _____

1 AN ACT concerning

2 **Election Law - Employee Membership Entities - Collection and Transmittal**
3 **of Campaign Contributions by Employer**

4 FOR the purpose of requiring an employer who withholds by payroll deduction an
5 employee's dues to an employee membership entity to also collect certain
6 campaign contributions specified by the employee for certain affiliated political
7 action committees and then transmit the contributions to the employee
8 membership entity in accordance with certain requirements; and generally
9 relating to an employer's collection and transmittal of an employee's campaign
10 contributions to an employee membership entity.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article - Election Law**

19 13-242.

20 (a) (1) In this section the following words have the meanings indicated.

1 (2) "Affiliated political action committee" means a political action
2 committee affiliated with an employee membership entity.

3 (3) "Employee membership entity" means an organization whose
4 membership includes employees of the employer.

5 (b) If an employer withholds from employees by payroll deduction the
6 employees' dues to an employee membership entity[.];

7 (1) [an] THE employee ALSO may [contribute] MAKE CONTRIBUTIONS
8 by payroll deduction to one or more affiliated political action committees selected by
9 the employee; AND

10 (2) THE EMPLOYER SHALL COLLECT THE CONTRIBUTIONS AND
11 TRANSMIT THEM TO THE EMPLOYEE MEMBERSHIP ENTITY DESIGNATED BY THE
12 EMPLOYEE IN ACCORDANCE WITH THE REQUIREMENTS OF SUBSECTION (C) OF THIS
13 SECTION.

14 (c) Periodic contributions collected by payroll deductions pursuant to a
15 program established under subsection (b) of this section shall be:

16 (1) combined and accumulated in a segregated escrow account
17 maintained solely for that purpose; and

18 (2) transmitted to the employee membership entity within 30 days of
19 being withheld, together with the information required under subsection (d)(1)
20 through (4) of this section.

21 (d) An affiliated political action committee, in conjunction with its employee
22 membership entity and the employer, shall keep detailed and accurate records of each
23 contribution under subsection (b) of this section, including:

24 (1) the name of the contributor;

25 (2) the date on which the contribution was made;

26 (3) the amount of the contribution;

27 (4) the name of the affiliated political action committee designated by
28 the employee to receive the contribution; and

29 (5) the date on which the contribution was received by the employee
30 membership entity and the affiliated political action committee.

31 (e) (1) Within 30 days after it receives a contribution under subsection (c) of
32 this section, the employee membership entity shall transmit the contribution:

33 (i) to its affiliated political action committee; or

1 (ii) if a contribution is designated for a political action committee
2 affiliated with a State or local chapter of the employee membership entity, to the
3 State or local chapter of the employee membership entity.

4 (2) Within 5 days after it receives a contribution under paragraph (1)(ii)
5 of this subsection, the State or local chapter of the employee membership entity shall
6 transmit the contribution to its affiliated political action committee.

7 (3) An employee membership entity, including a State or local chapter,
8 that transfers contributions in accordance with paragraphs (1) or (2) of this
9 subsection shall include the information recorded under subsection (d) of this section
10 that is received from the employer.

11 (f) An employer, employee membership entity, or affiliated political action
12 committee, may not solicit, receive, or use employee contributions in a manner that
13 would be prohibited under § 13-241(e) and (f) of this subtitle if performed by an
14 employer.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2003.
