## 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

## Chapter 411 of the Acts of 2001

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF15 MARYLAND, That:

16 (5) Prior to the payment of any funds under the provisions of this Act for the

17 purposes set forth in Section 1(3) above, the grantee shall provide and expend a

18 matching fund. No part of the grantee's matching fund may be provided, either

19 directly or indirectly, from funds of the State, whether appropriated or

20 unappropriated. No part of the fund may consist of real property, in kind

21 contributions, or funds expended prior to the effective date of this Act. In case of any

22 dispute as to the amount of the matching fund or what money or assets may qualify

1 as matching funds, the Board of Public Works shall determine the matter and the

2 Board's decision is final. The grantee has until June 1, [2003] 2005, to present

3 evidence satisfactory to the Board of Public Works that a matching fund will be

4 provided. If satisfactory evidence is presented, the Board shall certify this fact and

5 the amount of the matching fund to the State Treasurer, and the proceeds of the loan

6 equal to the amount of the matching fund shall be expended for the purposes provided

7 in this Act. Any amount of the loan in excess of the amount of the matching fund

8 certified by the Board of Public Works shall be canceled and be of no further effect.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 October 1, 2003.
