- 4 Administration to provide certain grants to certain local jurisdictions for the

- 7 procedures, and award certain grants; establishing the eligibility criteria for the

- termination of this Act; and generally relating to the Fast-Fill Compressed

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 18 MARYLAND, That the Laws of Maryland read as follows:
- 19 Article State Government
- 20 9-2006.
- 21 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
- 22 INDICATED.
- 23 (2) "FAST-FILL CNG STATION" MEANS A COMPRESSED NATURAL GAS
- 24 FUELING FACILITY THAT REFUELS COMPRESSED NATURAL GAS-POWERED
- 25 VEHICLES AT APPROXIMATELY THE SAME SPEED AS GASOLINE STATIONS REFUEL
- 26 GASOLINE-POWERED VEHICLES.
- 27 (3) "PROGRAM" MEANS THE FAST-FILL COMPRESSED NATURAL GAS
- 28 STATION PROGRAM.

- 1 (B) THERE IS A FAST-FILL COMPRESSED NATURAL GAS STATION PROGRAM IN 2 THE ADMINISTRATION.
- 3 (C) THE PURPOSE OF THE PROGRAM IS TO PROVIDE GRANTS TO LOCAL 4 JURISDICTIONS FOR THE CONSTRUCTION OF FAST-FILL CNG STATIONS.
- 5 (D) THE ADMINISTRATION SHALL:
- 6 (1) ADMINISTER THE PROGRAM;
- 7 (2) AWARD GRANTS FROM THE PROGRAM; AND
- 8 (3) ON OR BEFORE SEPTEMBER 1, 2003, DETERMINE THE INFORMATION 9 A LOCAL JURISDICTION MUST PROVIDE WHEN APPLYING FOR A GRANT FROM THE 10 PROGRAM AND ESTABLISH APPLICATION PROCEDURES FOR THE PROGRAM.
- 11 (E) TO BE ELIGIBLE FOR A GRANT UNDER THE PROGRAM, A LOCAL 12 JURISDICTION SHALL:
- 13 (1) SUBMIT AN APPLICATION ON OR AFTER NOVEMBER 1, 2003, TO THE 14 ADMINISTRATION; AND
- 15 (2) DEMONSTRATE THE ABILITY TO PROVIDE 25% OF THE COST OF THE 16 CONSTRUCTION OF A FAST-FILL CNG STATION FROM LOCAL FUNDS.
- 17 (F) THE ADMINISTRATION SHALL AWARD GRANTS TO THE FIRST FIVE LOCAL 18 JURISDICTIONS WHO:
- 19 (1) ARE ELIGIBLE TO RECEIVE GRANTS FROM THE PROGRAM; AND
- 20 (2) SUBMIT AN APPLICATION THAT MEETS THE REQUIREMENTS 21 ESTABLISHED UNDER SUBSECTION (D) OF THIS SECTION.
- 22 (G) A LOCAL JURISDICTION MAY ONLY USE A GRANT RECEIVED UNDER THIS
- 23 PROGRAM TO FUND 75% OF THE COST OF THE CONSTRUCTION OF A FAST-FILL CNG
- 24 STATION.
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 26 July 1, 2003. It shall remain effective for a period of 5 years and, at the end of June
- 27 30, 2008, with no further action required by the General Assembly, this Act shall be
- 28 abrogated and of no further force and effect.
