1 AN ACT concerning

2 Frederick County - Special Beer Festival License

- 3 FOR the purpose of authorizing the Board of License Commissioners for Frederick
- 4 County to issue a special beer festival license; specifying the scope of the license;
- 5 establishing a certain fee; specifying certain requirements imposed on
- 6 applicants for the license; requiring the Board to approve the time and location
- for the special beer festival under certain conditions; requiring the Board to
- 8 ensure the primary focus of the festival; requiring the Board to adopt certain
- 9 regulations for a certain purpose; providing that this Act does not prohibit a
- 10 licensee from holding another alcoholic beverages license of a different class or
- 11 nature; defining a certain term; and generally relating to special beer festival
- 12 licenses in Frederick County.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:

Article 2B - Alcoholic Beverages

- 2 8-803.
- 3 (A) IN THIS SECTION, "BOARD" MEANS THE BOARD OF LICENSE 4 COMMISSIONERS FOR FREDERICK COUNTY.
- 5 (B) THE BOARD MAY ISSUE A SPECIAL BEER FESTIVAL LICENSE.
- 6 (C) A SPECIAL BEER FESTIVAL LICENSE ENTITLES THE HOLDER TO DISPLAY
- 7 AND SELL AT RETAIL BEER FOR CONSUMPTION ON OR OFF THE LICENSED PREMISES
- 8 ON THE DAYS AND FOR THE HOURS DESIGNATED FOR THE SPECIAL BEER FESTIVAL
- 9 IN FREDERICK COUNTY.
- 10 (D) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE, AN
- 11 APPLICANT FOR A SPECIAL BEER FESTIVAL LICENSE SHALL BE THE HOLDER OF A
- 12 CURRENT RETAIL ALCOHOLIC BEVERAGES LICENSE ISSUED IN THE STATE, A CLASS 5
- 13 BREWERY LICENSE, OR A CLASS 7 MICRO-BREWERY LICENSE.
- 14 (E) THE LICENSE FEE IS \$15.
- 15 (F) THE BOARD SHALL:
- 16 (1) APPROVE ONE WEEKEND ANNUALLY FOR THE SPECIAL BEER
- 17 FESTIVAL THAT DOES NOT FALL ON THE DATES CHOSEN FOR THE CUMBERLAND AND
- 18 SHENANDOAH VALLEY WINE FESTIVAL IN WASHINGTON COUNTY OR THE MARYLAND
- 19 WINE FESTIVAL IN CARROLL COUNTY;
- 20 (2) APPROVE A NONLICENSED PREMISES IN FREDERICK COUNTY FOR
- 21 THE SPECIAL BEER FESTIVAL; AND
- 22 (3) ENSURE THAT THE PRIMARY FOCUS OF THE SPECIAL BEER
- 23 FESTIVAL IS THE PROMOTION OF MARYLAND BEER.
- 24 (G) THIS SECTION DOES NOT PROHIBIT THE LICENSEE FROM HOLDING
- 25 ANOTHER ALCOHOLIC BEVERAGES LICENSE OF A DIFFERENT CLASS OR NATURE.
- 26 (H) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION.
- 27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 28 June 1, 2003.
