- 3 FOR the purpose of proposing an amendment to the Maryland Constitution to 4 establish a Transportation Trust Fund to be used only for certain purposes;
- 5 providing for the crediting of certain revenues to the Transportation Trust Fund;
- 6 submitting this amendment to the qualified voters of the State of Maryland for
- 7 their adoption or rejection; and generally relating to a proposed amendment to
- 8 the Maryland Constitution to establish a Transportation Trust Fund to be used
- 9 only for certain purposes.
- 10 BY proposing an addition to the Constitution of Maryland
- 11 Article III Legislative Department
- 12 Section 52A
- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, (Three-fifths of all the members elected to each of the two Houses
- 15 concurring), That it be proposed that the Constitution of Maryland read as follows:
- 16 Article III Legislative Department
- 17 52A.
- 18 (1) THERE IS A TRANSPORTATION TRUST FUND.
- 19 (2) THE FUNDS IN THE TRANSPORTATION TRUST FUND MAY ONLY BE USED:
- 20 (I) FOR THE PURPOSE OF PAYING THE PRINCIPAL OF AND INTEREST ON
- 21 TRANSPORTATION BONDS AS THEY BECOME DUE AND PAYABLE; AND
- 22 (II) AFTER MEETING DEBT SERVICE REQUIREMENTS FOR
- 23 TRANSPORTATION BONDS, FOR ANY LAWFUL PURPOSE RELATED TO THE

- 1 CONSTRUCTION AND MAINTENANCE OF AN ADEQUATE HIGHWAY SYSTEM IN THE
- 2 STATE OR ANY OTHER TRANSPORTATION-RELATED PURPOSE.
- 3 (3) (I) NO PART OF THE TRANSPORTATION TRUST FUND MAY REVERT OR BE
- $4\,$ CREDITED TO THE GENERAL FUNDS OF THIS STATE.
- 5 (II) NO PART OF THE TRANSPORTATION TRUST FUND MAY REVERT OR BE
- 6 CREDITED TO A SPECIAL FUND OF THE STATE, UNLESS OTHERWISE PROVIDED BY
- 7 LAW THAT WAS IN EFFECT ON OR BEFORE OCTOBER 1, 2003.
- 8 (4) THERE SHALL BE CREDITED TO THE TRANSPORTATION TRUST FUND ALL
- 9 TAXES, FEES, CHARGES, AND REVENUES COLLECTED OR RECEIVED BY OR PAID,
- 10 APPROPRIATED, OR CREDITED TO THE TRANSPORTATION TRUST FUND, INCLUDING:
- 11 (I) THE CASH PROCEEDS OF THE SALE OF CONSOLIDATED
- 12 TRANSPORTATION BONDS, NOTES, OR OTHER EVIDENCES OF OBLIGATION ISSUED
- 13 FOR TRANSPORTATION PURPOSES;
- 14 (II) ANY GENERAL FUND APPROPRIATIONS;
- 15 (III) THE PROCEEDS OF ANY STATE LOAN OR FEDERAL GRANT MADE FOR 16 TRANSPORTATION PURPOSES:
- 17 (IV) ALL OF THE MOTOR FUEL TAX REVENUE;
- 18 (V) THE CORPORATE INCOME TAX REVENUE DISTRIBUTED TO THE
- 19 TRANSPORTATION TRUST FUND UNDER § 2-614 OF THE TAX GENERAL ARTICLE AS IT
- 20 WAS IN EFFECT AS OF OCTOBER 1, 2003;
- 21 (VI) ALL OF THE MOTOR VEHICLE EXCISE TAX REVENUE;
- 22 (VII) THE SALES AND USE TAX REVENUES FROM SHORT-TERM RENTAL
- 23 VEHICLES DISTRIBUTED TO THE TRANSPORTATION TRUST FUND UNDER § 2-1302.1 OF
- 24 THE TAX GENERAL ARTICLE AS IT WAS IN EFFECT AS OF OCTOBER 1, 2003; AND
- 25 (VIII) ALL VEHICLE REGISTRATION FEES.
- 26 SECTION 2. AND BE IT FURTHER ENACTED, That the General Assembly
- 27 determines that the amendment to the Constitution of Maryland proposed by this Act
- 28 affects multiple jurisdictions and that the provisions of Article XIV, Section 1 of the
- 29 Constitution concerning local approval of constitutional amendments do not apply.
- 30 SECTION 3. AND BE IT FURTHER ENACTED, That the aforegoing section
- 31 proposed as an amendment to the Constitution of Maryland shall be submitted to the
- 32 legal and qualified voters of this State at the next general election to be held in
- 33 November, 2004 for their adoption or rejection in pursuance of directions contained in
- 34 Article XIV of the Constitution of this State. At that general election, the vote on this
- 35 proposed amendment to the Constitution shall be by ballot, and upon each ballot
- 36 there shall be printed the words "For the Constitutional Amendment" and "Against
- 37 the Constitutional Amendment," as now provided by law. Immediately after the

- 1 election, all returns shall be made to the Governor of the vote for and against the
 2 proposed amendment, as directed by Article XIV of the Constitution, and further
 3 proceedings had in accordance with Article XIV.
