- 3 FOR the purpose of urging the Governor to direct the Secretary of Natural Resources
- 4 to take certain steps to provide certain incentives and relief to certain forestland
- 5 owners; acknowledging certain work performed by the State for certain
- 6 management and protection of public lands and endorsing certain efforts by the
- 7 Department of Natural Resources and the forest industry; providing that a copy
- 8 of this resolution be forwarded by the Department of Legislative Services to
- 9 certain individuals; and generally relating to sustainable forestry.
- WHEREAS, Careful stewardship of Maryland's forest resources is essential if
- 11 they are to continue to exist as an environmentally wise land use and if future
- 12 generations are to enjoy and prosper from them; and
- WHEREAS, Marylanders treasure the State's forest resources, but relatively
- 14 few are aware of the valuable role that private landowners, the Maryland
- 15 Department of Natural Resources, and the State's forest products companies play
- 16 individually and collectively to ensure that forests remain as a barrier against
- 17 indiscriminate land use changes, as protection for wildlife habitat and watersheds,
- 18 and as sustainable sources of quality forest products for the marketplace; and
- 19 WHEREAS, More than 2.56 million acres, or 41 percent, of Maryland's
- 20 landscape are covered with forests; and
- 21 WHEREAS, Because of increasing growth and development Maryland's
- 22 forestlands have been lost by, and are still threatened with, conversion to other land
- 23 uses; and
- 24 WHEREAS, Intelligent and sustainable management and retention of these
- 25 forests is vital to the health and welfare of the people of Maryland; and
- 26 WHEREAS, Approximately 130,600 private landowners in Maryland own and
- 27 manage 76 percent of the State's forests, resulting in major societal benefits to all

- 1 Marylanders, and as such should be rewarded with incentives for maintaining these
- 2 forests; and
- 3 WHEREAS, State agencies responsible for the management and protection of
- 4 approximately 375,000 acres of public land have for nearly 100 years demonstrated
- 5 the professional and scientific ability to be true stewards of the State's natural
- 6 resources by providing diverse habitat for wildlife, ensuring adequate protection for
- 7 sensitive areas including existing and potential old growth forests, protecting vital
- 8 watersheds, preventing soil erosion, and providing recreational opportunities for
- 9 millions of visitors while at the same time providing quality forest products to the
- 10 marketplace on a sustainable basis; and
- 11 WHEREAS, The State of Maryland has demonstrated its strong and continuing
- 12 commitment to sustainable forestry through its pursuit of third party certification;
- 13 and
- 14 WHEREAS, A viable forest products industry offers a market for forest
- 15 landowners thereby providing an essential financial incentive for those landowners to
- 16 retain their land in forests in face of development pressures; and
- WHEREAS, To ensure corporate sustainability, the industry acts as responsible
- 18 stewards of the forest resources through the adoption of best management practices,
- 19 the Maryland Master Logger program, and other industry-sponsored programs such
- 20 as the Sustainable Forest Initiatives (SFI); now, therefore, be it
- 21 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That the
- 22 General Assembly recognizes the commitment to the responsible use of forest
- 23 resources and the vital services provided by the private forestland owners of
- 24 Maryland, the State agencies responsible for the management and protection of
- 25 public forestlands, and the forest products industry; and be it further
- 26 RESOLVED, That the General Assembly believes that voluntary leadership by
- 27 private forestland owners, the State government, and the forest products industry is
- 28 the best way to ensure that productive and economically viable environmental
- 29 stewardship is sustained on the public and private forests throughout Maryland; and
- 30 be it further
- 31 RESOLVED, That the General Assembly urges the Governor to direct the
- 32 Secretary of the Department of Natural Resources to take all legal and necessary
- 33 steps to encourage private forestland owners to be responsible stewards of their land
- 34 by providing to them incentives and relief from unnecessary regulations as a way of
- 35 offsetting pressures on them to sell their land for development; and be it further
- 36 RESOLVED, That the General Assembly acknowledges the credible work
- 37 performed by the State of Maryland in carrying out its responsibilities for the
- 38 management and protection of public lands for all their benefits, including the
- 39 production of forest products, wildlife, fish, biodiversity, sensitive habitats, water and
- 40 recreation; and endorses the Department of Natural Resources' efforts to do so within
- 41 the framework of the sound science of sustainable forest management by pursuing
- 42 third party certification of the State's forests; and be it further

- 1 RESOLVED, That the General Assembly acknowledges and supports the forest
- 2 industry as a viable economic contributor to the financial welfare of the State and
- 3 recognizes the invaluable part the industry plays in the retention of the State's
- 4 forestland base by providing forestland owners with a return on their woodland
- 5 investment through the sale of forest products; and be it further
- 6 RESOLVED, That a copy of this Resolution be forwarded by the Department of
- 7 Legislative Services to the Honorable Robert L. Ehrlich, Jr., Governor of Maryland;
- 8 the Honorable Thomas V. Mike Miller, Jr., President of the Senate of Maryland; the
- 9 Honorable Michael E. Busch, Speaker of the House of Delegates; and the Honorable
- 10 Ronald Franks, Secretary-designee of the Department of Natural Resources and the
- 11 Secretary of the Department of the Environment.
