2 Somerset County - Ferry Companies - Franchises Company - Franchise

- 3 FOR the purpose of authorizing the County Commissioners of Somerset County to
- 4 grant one or more franchises a franchise for a ferry company to operate from

- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 22 MARYLAND, That the Laws of Maryland read as follows:

- 3 (a) (3) (I) NOTWITHSTANDING ANY ANTICOMPETITIVE EFFECT, THE
- 4 COUNTY COMMISSIONERS OF SOMERSET COUNTY MAY GRANT ONE OR MORE
- 5 FRANCHISES A FRANCHISE FOR A FERRY COMPANY TO OPERATE FROM BETWEEN
- 6 SOMERSET COUNTY <u>AND REEDVILLE, VIRGINIA</u> ON A NONEXCLUSIVE <u>AN EXCLUSIVE</u>

- 8 (II) BEFORE GRANTING A FRANCHISE FOR A FERRY COMPANY, THE
- 9 COUNTY COMMISSIONERS OF SOMERSET COUNTY SHALL REVIEW THE PROPOSED
- 10 BUSINESS AND FINANCIAL PLAN FOR OF THE FERRY COMPANY.
- 11 (III) 1. THE COUNTY COMMISSIONERS OF SOMERSET COUNTY
- 12 MAY ADOPT REGULATIONS TO CARRY OUT THE PROVISIONS OF THIS PARAGRAPH.
- 13 2. REGULATIONS ADOPTED UNDER THIS SUBPARAGRAPH
- 14 SHALL BE CONSISTENT WITH ANY REGULATIONS ADOPTED BY THE PUBLIC SERVICE

- 16 (IV) A FERRY COMPANY THAT IS GRANTED A FRANCHISE UNDER

- 18 PROHIBITED UNDER THE CRIMINAL LAW ARTICLE ON ANY FERRY THAT IT OPERATES

- 20 SECTION 2. AND BE IT FURTHER ENACTED, That the granting of a
- 21 franchise under this Act may not be construed to prohibit or restrict the operation of
- 22 any passenger ferry service between Crisfield and Smith Island or between Crisfield
- 23 and Tangier Island that is in existence on the effective date of this Act.
- 24 SECTION 2. 3. AND BE IT FURTHER ENACTED, That this Act shall take
- 25 effect October 1, 2003.
