2	<b>Local Correctional Facilities - Inmate Transfers</b>
4	FOR the purpose of authorizing the sheriff of a county or the governing body of a county or municipal corporation that operates a local correctional facility to
5	enter into certain agreements with other county sheriffs or counties or
6 7	municipal corporations to authorize the transfer of certain inmates between certain local correctional facilities under certain circumstances; prohibiting
8	certain local correctional facilities under certain circumstances; <u>promoting</u> certain agreements from authorizing the transfer of certain inmates from a local
9	correctional facility located outside of Baltimore County to the Baltimore
10	County Detention Center; and generally relating to local correctional facilities.
