#### **SENATE BILL 131**

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 2 MARYLAND, That the Laws of Maryland read as follows:

# Article - Courts and Judicial Proceedings

4 2-311.

5 (a) The sheriff of a county may establish and administer reasonable guidelines 6 in accordance with this section for disposing of abandoned, lawfully confiscated, or 7 recovered property that is in the possession of the sheriff's office.

8 (b) The guidelines shall provide that:

9 (1) (1) After <u>LAWFULLY CONFISCATED</u> property has been in the 10 possession of the sheriff for a period of {one year} 90 DAYS, notice of the sale of the 11 property shall be given by registered or certified mail to those persons entitled to its 12 possession and to those lienholders whose names and addresses can be ascertained by 13 the exercise of reasonable diligence; AND

# 14(II)AFTER ABANDONED OR RECOVERED PROPERTY HAS BEEN IN15THE POSSESSION OF THE SHERIFF FOR A PERIOD OF 90 DAYS, NOTICE OF THE SALE16OF THE PROPERTY SHALL BE GIVEN BY REGISTERED OR CERTIFIED MAIL TO THOSE17PERSONS ENTITLED TO ITS POSSESSION AND TO THOSE LIENHOLDERS WHOSE18NAMES AND ADDRESSES CAN BE ASCERTAINED BY THE EXERCISE OF REASONABLE19DILIGENCE;

20 (2) The property may be sold at public auction after a description of the

21 property and the time, place, and terms of the sale have been published in a

22 newspaper of general circulation in the county in each of 2 successive weeks;

(3) The amount received from the sale of property in accordance with24 this section shall be distributed in the following order of priority:

25 (i) To the sheriff, in an amount equal to the expense of the sale and 26 all expenses incurred while the property was in the sheriff's custody;

27 (ii) To lienholders in order of their priority; and

(iii) Subject to the provisions of item (4) of this subsection, to the
general fund of the county; and

30 (4) At any time within 3 years from the date of the sale of the property,

31 any person submitting satisfactory proof of the person's right to the possession of the

32 property shall be paid, without interest, the amount distributed to the general fund

33 pursuant to item (3) of this subsection, and after the expiration of 3 years from the

34 date of the sale, any claims shall be absolutely barred.

35 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect36 October 1, 2003.
