- Creation of a State Debt Prince George's County Ebenezer Community
 Life Center
- 4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$1,000,000,
- 5 the proceeds to be used as a grant to the Board of Directors of Ebenezer
- 6 Community Development Corporation for certain development or improvement
- 7 purposes; providing for disbursement of the loan proceeds, subject to a
- 8 requirement that the grantee provide and expend a matching fund; prohibiting
- 9 the use of the proceeds of the sale of the bonds and the matching fund for
- 10 religious purposes; and providing generally for the sale and issuance of bonds
- 11 evidencing the loan.
- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That:
- 14 (1) The Board of Public Works may borrow money and incur indebtedness on
- 15 behalf of the State of Maryland through a State loan to be known as the Prince
- 16 George's County Ebenezer Community Life Center Loan of 2003 in a total principal
- 17 amount equal to the lesser of (i) \$1,000,000 or (ii) the amount of the matching fund
- 18 provided in accordance with Section 1(5) below. This loan shall be evidenced by the
- 19 issuance, sale, and delivery of State general obligation bonds authorized by a
- 20 resolution of the Board of Public Works and issued, sold, and delivered in accordance
- 21 with §§ 8-117 through 8-124 of the State Finance and Procurement Article and
- 22 Article 31, § 22 of the Code.
- 23 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 24 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 25 § 8-122 of the State Finance and Procurement Article.
- 26 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 27 and first shall be applied to the payment of the expenses of issuing, selling, and
- 28 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 29 shall be credited on the books of the Comptroller and expended, on approval by the
- 30 Board of Public Works, for the following public purposes, including any applicable
- 31 architects' and engineers' fees: as a grant to the Board of Directors of Ebenezer
- 32 Community Development Corporation (referred to hereafter in this Act as "the

- 1 grantee") for the renovation, reconstruction, and capital equipping of two existing
- 2 buildings on Whitfield Chapel Road in Lanham, and the construction and capital
- 3 equipping of a new wing, to serve as a mixed educational, administrative, and
- 4 fellowship complex.
- 5 An annual State tax is imposed on all assessable property in the State in (4) 6 rate and amount sufficient to pay the principal of and interest on the bonds, as and
- when due and until paid in full. The principal shall be discharged within 15 years
- 8 after the date of issuance of the bonds.
- 9 Prior to the payment of any funds under the provisions of this Act for the
- purposes set forth in Section 1(3) above, the grantee shall provide and expend a 10
- matching fund. No part of the grantee's matching fund may be provided, either
- directly or indirectly, from funds of the State, whether appropriated or
- 13 unappropriated. No part of the fund may consist of in kind contributions. The fund
- 14 may consist of real property and funds expended prior to the effective date of this Act.
- 15 In case of any dispute as to the amount of the matching fund or what money or assets
- 16 may qualify as matching funds, the Board of Public Works shall determine the matter
- 17 and the Board's decision is final. The grantee has until June 1, 2005, to present
- 18 evidence satisfactory to the Board of Public Works that a matching fund will be
- 19 provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 20 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 21 equal to the amount of the matching fund shall be expended for the purposes provided
- in this Act. Any amount of the loan in excess of the amount of the matching fund
- certified by the Board of Public Works shall be canceled and be of no further effect.
- No portion of the proceeds of the loan or any of the matching funds may be 24
- 25 used for the furtherance of sectarian religious instruction, or in connection with the
- 26 design, acquisition, or construction of any building used or to be used as a place of
- 27 sectarian religious worship or instruction, or in connection with any program or
- 28 department of divinity for any religious denomination. Upon the request of the Board
- 29 of Public Works, the grantee shall submit evidence satisfactory to the Board that none
- 30 of the proceeds of the loan or any matching funds have been or are being used for a
- 31 purpose prohibited by this Act.
- 32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 33 June 1, 2003.
