- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12

- The Board of Trustees shall grant an ordinary disability retirement 16 17 allowance to a member if:
- the member has at least 5 years of eligibility service; and 18 (1)
- 19 the medical board certifies that: (2)
- 20 the member is mentally or physically incapacitated for the (i)
- 21 further performance of the normal duties of the member's position;
- 22 (ii) the incapacity is likely to be permanent; and
- 23 (iii) the member should be retired.

- 10 (3) THE BOARD OF TRUSTEES DENIED THE MEMBER A SPECIAL
- 11 DISABILITY RETIREMENT ALLOWANCE UNDER § 29-111 OF THIS SUBTITLE, ON OR
- 12 BEFORE SEPTEMBER 1, 1995;
- 13 (4) THE MEMBER WITHDREW THE MEMBER'S ACCUMULATED
- 14 CONTRIBUTIONS IN THE STATE POLICE RETIREMENT SYSTEM ON OR BEFORE
- 15 NOVEMBER 1, 1996; AND
- 16 (5) ON OR BEFORE DECEMBER 31, 2003, THE MEMBER PAYS TO THE
- 17 BOARD OF TRUSTEES IN A SINGLE PAYMENT THE MEMBER'S ACCUMULATED
- 18 CONTRIBUTIONS THAT WERE WITHDRAWN FROM THE STATE POLICE RETIREMENT
- 19 SYSTEM ON OR BEFORE NOVEMBER 1, 1996.
- 20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 21 July 1, 2003.
