3 FOR the purpose of requiring that every deputy clerk or sheriff in Montgomery 4 County take and sign the oath or affirmation prescribed by the Maryland 5 Constitution; and generally relating to oaths of office.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

15 (a) Every auditor, clerk, sheriff, constable, commissioner, surveyor, or other 16 officer before he assumes the duties of his office, shall take and sign the oath or 17 affirmation prescribed by the Constitution.
(b) [Every] EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, 19 EVERY deputy clerk or sheriff shall take and subscribe the following oath or 20 affirmation: "I, A.B., do swear (or affirm) that I will not for lucre or malice delay any 21 person applying to me for any business belonging to the office I officiate in, and that 22 I will not directly or indirectly ask, take, exact, demand, or receive from or charge to

- 1 any such person to my own use any fee or reward whatsoever for any services I may 2 do as deputy of the said office, and that in making out the office fees I will not
- 3 wittingly or willingly charge other or higher fees than are allowed by law."
- 4 (c) (1) In addition to the oath or affirmation required under subsection (b) of
- 5 this section, in St. Mary's County, every deputy sheriff shall take and subscribe the
- 6 following oath or affirmation: "I, A.B., do solemnly swear (or affirm) that I will bear
- 7 true faith and allegiance to the United States of America and to the State of
- 8 Maryland; that I will serve honestly and faithfully to uphold and defend the
- 9 Constitution of the United States and the Constitution of Maryland: that I will
- 10 enforce the laws of St. Mary's County, and the State of Maryland; and that I will obey

- 29 circuit court shall take the oath before a judge of the court.
- 30 (3) The clerk of an appellate court shall take the oath before the
- 31 Governor.
- 32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 33 October 1, 2003.
