## A BILL ENTITLED

## 1 AN ACT concerning

## 2 Creation of a State Debt - Frederick County - American Red Cross

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$400,000,
- the proceeds to be used as a grant to the Board of Directors of the Frederick 4
- 5 County Chapter of the American Red Cross for certain development or
- 6 improvement purposes; providing for disbursement of the loan proceeds, subject
- 7 to a requirement that the grantee provide and expend a matching fund; and
- providing generally for the issuance and sale of bonds evidencing the loan. 8

## 9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 10 MARYLAND, That:
- 11 The Board of Public Works may borrow money and incur indebtedness on
- 12 behalf of the State of Maryland through a State loan to be known as the Frederick
- 13 County American Red Cross Loan of 2003 in a total principal amount equal to the
- 14 lesser of (i) \$400,000 or (ii) the amount of the matching fund provided in accordance
- 15 with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and
- 16 delivery of State general obligation bonds authorized by a resolution of the Board of
- 17 Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 18 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 19 The bonds to evidence this loan or installments of this loan may be sold as
- 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 21 § 8-122 of the State Finance and Procurement Article.
- 22 The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 23 and first shall be applied to the payment of the expenses of issuing, selling, and
- 24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 25 shall be credited on the books of the Comptroller and expended, on approval by the
- 26 Board of Public Works, for the following public purposes, including any applicable
- 27 architects' and engineers' fees: as a grant to the Board of Directors of the Frederick
- 28 County Chapter of the American Red Cross (referred to hereafter in this Act as "the
- 29 grantee") for the acquisition of adjacent land and renovation of the headquarters of
- 30 the Frederick County Chapter of the American Red Cross, located in Walkersville.

- 1 (4) An annual State tax is imposed on all assessable property in the State in 2 rate and amount sufficient to pay the principal of and interest on the bonds, as and
- 3 when due and until paid in full. The principal shall be discharged within 15 years
- 4 after the date of issuance of the bonds.
- 5 (5) Prior to the payment of any funds under the provisions of this Act for the
- 6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 7 matching fund. No part of the grantee's matching fund may be provided, either
- 8 directly or indirectly, from funds of the State, whether appropriated or
- 9 unappropriated. No part of the fund may consist of real property, in kind
- 10 contributions, or funds expended prior to the effective date of this Act. In case of any
- 11 dispute as to the amount of the matching fund or what money or assets may qualify
- 12 as matching funds, the Board of Public Works shall determine the matter and the
- 13 Board's decision is final. The grantee has until June 1, 2005, to present evidence
- 14 satisfactory to the Board of Public Works that a matching fund will be provided. If
- 15 satisfactory evidence is presented, the Board shall certify this fact and the amount of
- 16 the matching fund to the State Treasurer, and the proceeds of the loan equal to the
- 17 amount of the matching fund shall be expended for the purposes provided in this Act.
- 18 Any amount of the loan in excess of the amount of the matching fund certified by the
- 19 Board of Public Works shall be canceled and be of no further effect.
- 20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 21 June 1, 2003.
