## Preamble

20 WHEREAS, Senior citizens in Maryland face unique challenges in accessing

21 safe, available, and affordable transportation for a variety of medical, routine, social,22 and personal needs; and

23 WHEREAS, The federal, State, and local resources available to subsidize

24 transportation for seniors, and the existing transportation services offered by State,

25 local, and private providers, do not adequately meet the needs of seniors for

26 door-to-door, nonfixed-route, and on-demand transportation options; and

WHEREAS, The transportation challenges faced by seniors vary significantly
 across the State depending on whether they live in urban, suburban, or rural settings;
 and

1 WHEREAS, Senior citizens make up more than 15% of Maryland's population 2 and, by 2020, that percentage is expected to grow to 23%; now, therefore,

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

8 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS 9 INDICATED.

10 (B) "DOOR-TO-DOOR TRANSPORTATION" MEANS PROVIDING, THROUGH
11 PREARRANGED APPOINTMENT, SAFE ESCORT FROM A DEPARTURE POINT, INTO AND
12 OUT OF A TRANSPORT VEHICLE AND TO THE DOOR OF THE DESTINATION.

22 (F) "PROGRAM PARTICIPANT" MEANS A PROGRAM APPLICANT THAT HAS BEEN 23 APPROVED FOR PARTICIPATION IN THE PROGRAM.

24 (G) "SENIOR" MEANS AN INDIVIDUAL AGE 60 OR OLDER.

26 (A) THERE IS A MARYLAND SENIOR RIDES DEMONSTRATION PROGRAM IN THE 27 ADMINISTRATION.

28 (B) THE PURPOSE OF THE PROGRAM IS TO ENCOURAGE REGIONAL
29 PROVIDERS TO PROVIDE DOOR-TO-DOOR TRANSPORTATION FOR LOW-INCOME TO
30 MODERATE-INCOME SENIORS.

31 (C) THE ADMINISTRATION SHALL AWARD A GRANT TO QUALIFIED PROGRAM

3 (1) PROVIDE DOOR-TO-DOOR TRANSPORTATION FOR LOW-INCOME TO 4 MODERATE-INCOME SENIORS WHO HAVE DIFFICULTY ACCESSING OR USING OTHER 5 EXISTING TRANSPORTATION SYSTEMS;

6 (2) USE PRIMARILY VOLUNTEER DRIVERS WHO DRIVE THEIR OWN 7 VEHICLES;

8 (3) USE A DISPATCHER SYSTEM TO RESPOND QUICKLY TO REQUESTS
9 FROM LOW-INCOME TO MODERATE-INCOME SENIORS FOR TRANSPORTATION TO
10 AND FROM APPOINTMENTS; AND

11 (4) DEFINE A GEOGRAPHIC AREA FOR WHICH DOOR-TO-DOOR 12 TRANSPORTATION IS PROVIDED.

13 (E) A PROGRAM PARTICIPANT MAY PROVIDE DOOR-TO-DOOR
14 TRANSPORTATION TO AN ELIGIBLE SENIOR WHO DOES NOT RESIDE IN THE
15 GEOGRAPHIC AREA DEFINED BY THE PROGRAM PARTICIPANT UNDER SUBSECTION

29 Maryland Senior Rides Demonstration Program. The evaluation shall include the

30 number, size, type, and location of projects funded by the Program; the extent to

31 which the Program is filling the need for door-to-door transportation for low-income

32 to moderate-income seniors as those terms are defined in § 7-1001 of the

33 Transportation Article as enacted by this Act; any innovations in public-private

34 cooperation and risk management that result from the Program; and any other

35 information necessary to effectively evaluate the Program.
