- 11 termination of the terms of the appointed members of the County Board;
- 12 requiring the County Board to meet at certain intervals; providing for the
- 13 effective date of certain provisions of this Act; providing for the termination of

- 30 (4) WILLFUL NEGLECT OF DUTY; OR

(a) (1) The term of the appointed member from councilmanic district 3,
 2 scheduled to expire on June 30, 2003, shall terminate at the end of December 31,
 3 2004;

4 (2) The term of the appointed member from councilmanic district 1, 5 scheduled to expire on June 30, 2005, shall terminate at the end of December 31, 6 2004; and

7 (3) The term of the appointed member from councilmanic district 5,
8 scheduled to expire on June 30, 2004, shall terminate at the end of December 31,
9 2004.

10 (b) (1) The term of the appointed member from councilmanic district 4, 11 scheduled to expire on June 30, 2005, shall terminate at the end of December 31, 12 2006;

13 (2) The term of the appointed member from councilmanic district 2,
14 scheduled to expire on June 30, 2006, shall terminate at the end of December 31,
15 2006; and

SECTION 6. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall
take effect on the taking effect of the termination provision specified in Section 20 of
Chapter 289 of the Acts of the General Assembly of 2002. If that termination provision
takes effect, Section 1 of this Act shall be abrogated and of no further force and effect.
This Act may not be interpreted to have any effect on that termination provision.
