A BILL ENTITLED

1 AN ACT concerning

2 **Work, Not Welfare, and Qualifying Employees with Disabilities Tax Credits**

3 FOR the purpose of altering certain termination provisions and dates of applicability

4 for certain tax credits allowed to employers that hire certain qualified
5 employment opportunity employees or certain qualifying individuals with
6 disabilities; and generally relating to certain tax credits allowed to employers
7 that hire certain qualified employment opportunity employees or certain
8 qualifying individuals with disabilities.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

26 MARYLAND, That the Laws of Maryland read as follows:

1 **Chapter 492 of the Acts of 1995, as amended by Chapter 10 of the Acts of 1996,**
2 **Chapters 598 and 599 of the Acts of 1998, and Chapter 448 of the Acts of 2000**

3 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
4 July 1, 1995, and shall be applicable to all taxable years beginning after December 31,
5 1994 but before January 1, [2006] 2009; provided, however, that the tax credit under
6 Article 88A, § 54 of the Code, as enacted under Section 1 of this Act, shall be allowed
7 only for employees hired on or after June 1, 1995 but before July 1, [2003] 2006; and
8 provided further that any excess credits under Article 88A, § 54 of the Code may be
9 carried forward and, subject to the limitations under Article 88A, § 54 of the Code,
10 may be applied as a credit for taxable years beginning on or after January 1, [2006]
11 2009. Except as otherwise provided in this Section, this Act shall remain in effect for
12 a period of [8] 11 years and at the end of June 30, [2003] 2006, with no further action
13 required by the General Assembly, this Act shall be abrogated and of no further force
14 and effect.

17 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall be
18 applicable to all taxable years beginning after December 31, 1996 but before January
19 1, [2006] 2009; provided, however, that the tax credit under § 21-309 of the Education
20 Article, as enacted under Section 1 of this Act, shall be allowed only for employees
21 hired on or after October 1, 1997 but before July 1, [2003] 2006; and provided further
22 that any excess credits under § 21-309 of the Education Article may be carried
23 forward and, subject to the limitations under § 21-309 of the Education Article, may
24 be applied as a credit for taxable years beginning on or after January 1, [2006] 2009.

25 SECTION 6. AND BE IT FURTHER ENACTED, That, subject to the provisions
26 of Section 4 of this Act, this Act shall take effect October 1, 1997. It shall remain in
27 effect for a period of [5] 8 years and 9 months and at the end of June 30, [2003] 2006,
28 with no further action required by the General Assembly, this Act shall be abrogated
29 and of no further force and effect.

30 **Chapter 113 of the Acts of 1997, as amended by Chapter 614 of the Acts of**
31 **1998 and Chapter 448 of the Acts of 2000**

32 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall be
33 applicable to all taxable years beginning after December 31, 1996 but before January
34 1, [2006] 2009; provided, however, that the tax credit under § 21-309 of the Education
35 Article, as enacted under Section 1 of this Act, shall be allowed only for employees
36 hired on or after October 1, 1997 but before July 1, [2003] 2006; and provided further
37 that any excess credits under § 21-309 of the Education Article may be carried
38 forward and, subject to the limitations under § 21-309 of the Education Article, may
39 be applied as a credit for taxable years beginning on or after January 1, [2006] 2009.

40 SECTION 6. AND BE IT FURTHER ENACTED, That, subject to the provisions
41 of Section 4 of this Act, this Act shall take effect October 1, 1997. It shall remain in
42 effect for a period of [5] 8 years and 9 months and at the end of June 30, [2003] 2006,

1 with no further action required by the General Assembly, this Act shall be abrogated
2 and of no further force and effect.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
4 July 1, 2003.
