1 AN ACT concerning

2 **Consolidation of Rural Development Programs**

3 FOR the purpose of renaming the Forvm for Rural Maryland to be the Rural
4 Maryland Council; providing for the purpose of the Council; expanding the
5 Council's membership; requiring the Council to elect one or more Vice
6 Chairmen; altering and expanding the Council's Executive Board membership
7 and clarifying its duties; authorizing the Council's Chairman to establish certain
8 working committees; requiring the Council's Executive Director to serve at the
9 pleasure of the Executive Board; placing the Council, for administrative and
10 budgetary reasons, under the Maryland Department of Agriculture and
11 requiring the Department to provide certain funding, staff, and resources for the
12 Council; requiring the Secretary of Agriculture to include the Council's budget
13 request that is provided to the Department of Budget and Management with the
14 budget request of the Maryland Department of Agriculture; providing for the
15 location of the Council's principal office; transferring from the Board of Public

1 Works to the Council the administration of the Maryland Agricultural Education
2 and Rural Development Assistance Fund; transferring from the Department of
3 Business and Economic Development to the Council the administration of
4 awarding certain grants; expanding the membership of the Maryland
5 Agricultural Education and Rural Development Assistance Board and requiring
6 it to make certain binding recommendations to the Council; authorizing certain
7 agencies to assist the Council with administering certain grants; altering
8 certain reporting requirements for certain grant recipients and the Council;
9 declaring the intent of the General Assembly; repealing the termination
10 provision for the Maryland Agricultural Education and Rural Development
11 Assistance Fund; providing for the transition under this Act; providing for the
12 application of this Act; making the provisions of this Act severable; defining
13 certain terms; and generally relating to the Forvm for Rural Maryland and the
14 Maryland Agricultural Education and Rural Development Assistance Fund Act
15 of 2000.

8 Preamble

9 WHEREAS, Many rural communities in Maryland are currently facing difficult
10 challenges relating to changing economic condition, an aging population, an
11 inadequate access to quality health care and other services, and a deteriorating or
12 inadequate physical infrastructure; and

13 WHEREAS, Local governments, educational institutions, and private service
14 providers in rural areas are increasingly unable to meet all the economic
15 development, community development, and human services needs of approximately
16 1.4 million citizens residing in the rural counties and municipalities; and

17 WHEREAS, Agricultural and other resource-based enterprises continue to
18 underpin the local economies of rural communities, but are increasingly under threat
19 from national and international competition, land development pressure, and
20 regulatory influences; and

21 WHEREAS, The United States Congress passed The Farm Security and Rural
22 Investment Act of 2002 which potentially provides Marylanders with opportunities to
23 seek assistance on a variety of rural concerns including agricultural and forest land
24 preservation, soil and water conservation, agribusiness development, small
25 community water and wastewater infrastructure, safe and affordable housing,
26 broadband telecommunications access, and other community facilities; and

27 WHEREAS, The State's existing rural capacity development programs could be
28 combined to provide for more efficient programmatic and policy development
29 coordination, take better advantage of new opportunities, and enhance the
30 capabilities of Maryland's rural communities to deal with the difficult challenges they
31 face; now, therefore,

32 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
33 MARYLAND, That the Laws of Maryland read as follows:

Article 41 - Governor - Executive and Administrative Departments

Title 15. [Forvm for] Rural Maryland COUNCIL.

4 IN THIS TITLE, "COUNCIL" MEANS THE RURAL MARYLAND COUNCIL.

6 There is a [Forvm for] Rural Maryland COUNCIL.

7 15-102.

8 (A) The [Forvm is a rural development council] COUNCIL IS DESIGNATED AS
9 A STATE RURAL DEVELOPMENT COUNCIL THAT BRINGS TOGETHER CITIZENS AND
10 REPRESENTATIVES OF PUBLIC SECTOR ENTITIES AND PRIVATE SECTOR
11 ORGANIZATIONS TO COLLABORATIVELY ADDRESS PROBLEMS AND CHALLENGES
12 FACING RURAL COMMUNITIES IN MARYLAND.

13 (B) The [Forvm] COUNCIL may undertake any activity that addresses issues
14 and concerns of the citizens of rural Maryland as long as the activity is not
15 inconsistent with the [Memorandum of Understanding signed by the Governor and
16 the Secretary of the United States Department of Agriculture concerning the
17 operation of the Forvm] PROVISIONS OF THE FARM SECURITY AND RURAL
18 INVESTMENT ACT OF 2002 (P.L. 107-171, SECTION 6021) REGARDING THE NATIONAL
19 RURAL DEVELOPMENT PARTNERSHIP AND STATE RURAL DEVELOPMENT COUNCILS.

20 15-103.

21 (a) The membership of the [Forvm] COUNCIL is open to any citizen of
22 Maryland who [subscribes to the goals of the Forvm and who] has an interest in
23 IMPROVING THE QUALITY OF LIFE IN rural Maryland.

24 (b) The [Forvm] COUNCIL shall include:

25 (1) The Governor or the Governor's designee;

26 (2) As nonvoting members, three members of the Maryland State
27 Senate, appointed by the President of the Senate, one each from the three rural
28 regions of the State;

29 (3) As nonvoting members, three members of the Maryland House of
30 Delegates, appointed by the Speaker of the House of Delegates, one each from the
31 three rural regions of the State;

32 (4) AS A NONVOTING MEMBER, ONE MEMBER OF THE MARYLAND STATE
33 SENATE OR MARYLAND HOUSE OF DELEGATES REPRESENTING HARFORD COUNTY
34 SELECTED JOINTLY BY THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE
35 HOUSE OF DELEGATES;

1 [(4)] (5) As determined under the bylaws of the [Forvm] COUNCIL:

2 (i) Representatives from LOCAL, STATE, AND federal agencies that
3 serve rural interests; and

4 (ii) Representatives from private sector organizations, including
5 rural-based for-profit and nonprofit organizations and rural client groups; and

6 [(5)] (6) Any other individual who elects to join the [Forvm] COUNCIL
7 and who qualifies under subsection (a) of this section.

8 15-104.

9 (a) From among its members, the [Forvm] COUNCIL annually shall elect a
10 Chairman AND ONE OR MORE VICE CHAIRMEN.

11 (b) The [Forvm] COUNCIL shall adopt bylaws to regulate its affairs and the
12 orderly conduct of its business.

13 (c) (1) The [Forvm] COUNCIL shall establish an Executive Board.

14 (2) The Executive Board shall include:

15 (i) The Chairman of the [Forvm] COUNCIL, who shall serve as
16 Chairman of the Executive Board;

17 (ii) The Governor or the Governor's designee;

18 (III) THE SECRETARY OF AGRICULTURE OR THE SECRETARY'S
19 DESIGNEE;

20 (IV) THE SECRETARY OF BUSINESS AND ECONOMIC DEVELOPMENT
21 OR THE SECRETARY'S DESIGNEE;

22 (V) THE SECRETARY OF HOUSING AND COMMUNITY
23 DEVELOPMENT OR THE SECRETARY'S DESIGNEE;

24 (VI) THE SECRETARY OF HEALTH AND MENTAL HYGIENE OR THE
25 SECRETARY'S DESIGNEE;

26 (VII) THE SECRETARY OF NATURAL RESOURCES OR THE
27 SECRETARY'S DESIGNEE;

28 (VIII) THE DIRECTOR OF MARYLAND COOPERATIVE EXTENSION OR
29 THE DIRECTOR'S DESIGNEE;

30 [(iii)] (IX) Two representatives of the Maryland Municipal League,
31 selected from rural regions of the State;

32 [(iv)] (X) Two representatives of the Maryland Association of
33 Counties, selected from rural regions of the State;

1 [(v)] (XI) One OR MORE [representative] REPRESENTATIVES of [a]
2 federal [agency] AGENCIES, SELECTED IN ACCORDANCE WITH THE BYLAWS OF THE
3 COUNCIL;

4 [(vi)] (XII) One representative of the Delmarva Advisory Council;

5 [(vii)] (XIII) One representative of [the Tri-County Council for
6 Southern Maryland] EACH OF THE RURAL REGIONAL PLANNING AND DEVELOPMENT
7 COUNCILS IN MARYLAND;

8 [(viii)] (XIV) One representative of [the Tri-County Council for
9 Western Maryland] EACH OF THE RESOURCE, CONSERVATION, AND DEVELOPMENT
10 COUNCILS IN MARYLAND;

11 (XV) ONE REPRESENTATIVE SELECTED, IN ACCORDANCE WITH THE
12 BYLAWS OF THE COUNCIL, FROM GARRETT, ALLEGANY, AND WASHINGTON
13 COUNTIES;

14 [(ix)] (XVI) One representative selected, in accordance with the
15 bylaws of the [Forvm] COUNCIL, from Carroll County or Frederick County;

16 (XVII) ONE REPRESENTATIVE SELECTED, IN ACCORDANCE WITH THE
17 BYLAWS OF THE COUNCIL, FROM CALVERT, CHARLES, OR ST. MARY'S COUNTIES;

18 [(x)] (XVIII) One representative selected, in accordance with the
19 bylaws of the [Forvm] COUNCIL, from Cecil or Harford County;

20 (XIX) ONE REPRESENTATIVE SELECTED, IN ACCORDANCE WITH THE
21 BYLAWS OF THE COUNCIL, FROM DORCHESTER, SOMERSET, WICOMICO, OR
22 WORCESTER COUNTIES;

23 [(xi)] (XX) One representative of the private FOR-PROFIT sector,
24 selected [by those individuals representing for-profit organizations on the Forvm] IN
25 ACCORDANCE WITH THE BYLAWS OF THE COUNCIL;

26 [(xii)] (XXI) One representative of the nonprofit sector, selected [by
27 those individuals representing nonprofit organizations on the Forvm] IN
28 ACCORDANCE WITH THE BYLAWS OF THE COUNCIL;

29 [(xiii)] (XXII) As [a] nonvoting [member] MEMBERS, [one senator
30 or] THE SENATOR AND delegate appointed to the [Forvm] COUNCIL under §
31 15-103(b)(2) [or] AND (3) of this title from the Eastern Shore region of the State;

32 [(xiv)] (XXIII) As [a] nonvoting [member] MEMBERS, [one senator
33 or] THE SENATOR AND delegate appointed to the [Forvm] COUNCIL under §
34 15-103(b)(2) [or] AND (3) of this title from the Southern Maryland region of the
35 State;

36 [(xv)] (XXIV) As [a] nonvoting [member] MEMBERS, [one senator
37 or] THE SENATOR AND delegate appointed to the [Forvm] COUNCIL under §

1 15-103(b)(2) [or] AND (3) of this title from the Western Maryland region of the State;
2 [and]

3 (XXV) AS A NONVOTING MEMBER, ONE SENATOR OR DELEGATE
4 APPOINTED TO THE COUNCIL UNDER § 15-103(B)(4) OF THIS TITLE FROM HARFORD
5 COUNTY;

6 [(xvi)] (XXVI) [Eight] TWO at-large members, selected by the
7 membership of the [Forvm] COUNCIL; AND

8 (XXVII) NO MORE THAN SIX MEMBERS REPRESENTING STATEWIDE
9 NONPROFIT ORGANIZATIONS WITH A RURAL FOCUS, SELECTED IN ACCORDANCE
10 WITH THE BYLAWS OF THE COUNCIL.

11 (3) Members of the Executive Board shall be selected and serve in
12 accordance with the bylaws of the [Forvm] COUNCIL.

13 (d) The [Forvm] COUNCIL may expand the membership of the Executive
14 Board through the bylaws of the [Forvm] COUNCIL.

15 15-105.

16 (a) The Executive Board shall make recommendations on [policy]
17 PROGRAMMATIC OR REGULATORY matters [to the Forvm and on implementation of
18 policies that the Forvm adopts] OF CONCERN TO RURAL COMMUNITIES AFTER A
19 CONSENSUS OF OPINION HAS EMERGED.

20 (b) With the consent of the Executive Board, the Chairman may establish
21 subcommittees OR WORKING COMMITTEES consisting of members of the [Forvm]
22 COUNCIL AND INTERESTED PARTIES to address or study specific issues.

23 15-106.

24 (a) The [Forvm] COUNCIL shall hire an Executive Director.

25 (b) The Executive Director shall:

26 (1) Be responsible for the day-to-day operations of the [Forvm]
27 COUNCIL; and

28 (2) Assist in the development of policy recommendations for
29 consideration by the [Forvm] COUNCIL or by the Executive Board.

30 (c) The Executive Director serves at the pleasure of the [Forvm] EXECUTIVE
31 BOARD.

32 15-107.

33 (a) The [Forvm] COUNCIL is an independent unit in the Executive Branch of
34 State government [and may not be placed by the Governor in any principal

1 department] THAT FOR ADMINISTRATIVE AND BUDGETARY PURPOSES SHALL BE
2 PLACED UNDER THE MARYLAND DEPARTMENT OF AGRICULTURE.

3 (b) The [Forvm] COUNCIL is exempt from the provisions of:

4 (1) Division I of the State Personnel and Pensions Article;

5 (2) Division II of the State Finance and Procurement Article except as
6 otherwise provided in § 11-203(b) of that article; and

7 (3) Title 10, Subtitle 1 of the State Government Article.

8 (c) (1) The [Forvm] COUNCIL shall receive annual funding through an
9 appropriation [in the State] INCLUDED AS PART OF THE budget OF THE MARYLAND
10 DEPARTMENT OF AGRICULTURE.

11 (2) The Secretary of [Business and Economic Development]
12 AGRICULTURE shall include without revision the budget request of the [Forvm]
13 COUNCIL THAT IS PROVIDED TO THE DEPARTMENT OF BUDGET AND MANAGEMENT
14 TOGETHER with the budget request of the MARYLAND Department of [Business and
15 Economic Development] AGRICULTURE.

16 (d) The MARYLAND Department of [Business and Economic Development]
17 AGRICULTURE shall provide the [Forvm] COUNCIL with necessary staff and
18 resources, including office space [if desired by the Forvm].

19 (e) Each unit in the Executive Branch of State government shall participate in
20 the deliberations of the [Forvm] COUNCIL and work with the [Forvm] COUNCIL on
21 matters relating to the unit.

22 (f) The Attorney General shall serve as legal advisor to the [Forvm]
23 COUNCIL.

24 15-108.

25 The [Forvm] COUNCIL may:

26 (1) Maintain [an] A PRINCIPAL office at a location [that the Forvm
27 designates in accordance with the Forvm budget] IN THE CENTRAL REGION OF THE
28 STATE THAT IS ACCESSIBLE TO RURAL CITIZENS;

29 (2) Employ, as regular employees or as independent contractors, staff
30 that the [Forvm] COUNCIL considers necessary in accordance with the [Forvm]
31 COUNCIL budget;

32 (3) Enter into contracts;

33 (4) Accept grants;

34 (5) Accept assistance of any kind from the federal government, other
35 units of State government, or local governments, or from any private sources; and

1 (6) Do all things necessary or convenient to carry out its purpose.

2 15-109.

3 (a) The [Forvm] COUNCIL shall publish an annual report of the activities of
4 the [Forvm] COUNCIL.

5 (b) The report shall be submitted to the Governor and, in accordance with §
6 2-1246 of the State Government Article, to the General Assembly.

7 15-110.

8 (a) (1) This section only applies if the [Forvm] COUNCIL is dissolved.

9 (2) This section does not apply to the disposition of any funds or other
10 assets of the State.

11 (b) After paying or making provision for the payment of any liability of the
12 [Forvm] COUNCIL, the [Forvm] COUNCIL shall dispose of all assets of the [Forvm]
13 COUNCIL in a manner consistent with the purposes of the [Forvm] COUNCIL by
14 transferring the assets to an organization that is organized and operated exclusively
15 for charitable, educational, religious, or scientific purposes and that is then qualified
16 as an exempt organization under § 501(c)(3) of the Internal Revenue Code.

17 (c) If the [Forvm] COUNCIL fails to dispose of any assets, the circuit court for
18 the county in which the [Forvm] COUNCIL has its principal office shall dispose of the
19 assets in a manner consistent with subsection (b) of this section.

20 **Article - State Finance and Procurement**

21 2-206.

22 (a) (1) In this section the following words have the meanings indicated.

23 (2) "Board" means the Maryland Agricultural Education and Rural
24 Development Assistance Board.

25 (3) "COUNCIL" MEANS THE RURAL MARYLAND COUNCIL ESTABLISHED
26 UNDER ARTICLE 41, TITLE 15 OF THE CODE.

27 (4) "Fund" means the Maryland Agricultural Education and Rural
28 Development Assistance Fund.

29 (b) The General Assembly finds and declares that:

30 (1) many nonprofit organizations that serve the needs of the rural areas
31 of the State experience fiscal difficulties in addressing the areas of economic and
32 community development and agriculture and forestry education because of the
33 inadequacy of funding resources for them;

1 (2) these organizations do not have the access to private and public
2 sources of funding that are generally more available to nonprofit groups that serve
3 the needs of the metropolitan areas of the State; and

4 (3) as a result, the rural areas of the State face a serious deficit of
5 resources where the need, in many instances, is greatest.

6 (c) (1) There is a Maryland Agricultural Education and Rural Development
7 Assistance Fund that shall be administered by the [Board of Public Works] COUNCIL.

8 (2) The purpose of the Fund is to provide funding:

9 (i) to rural regional planning and economic development
10 organizations and rural community development programs whose missions and work
11 have statewide implications and merit State support; and

12 (ii) to augment the efforts of advanced technology centers AND
13 SIMILAR PROGRAMS that serve agricultural and natural resources based small
14 businesses in rural areas through community colleges.

15 (3) (i) The Fund is a continuing, nonlapsing fund which is not subject
16 to § 7-302 of this article.

17 (ii) The Treasurer shall separately hold and the Comptroller shall
18 account for the Fund.

19 (iii) The Treasurer may invest moneys in the Fund in the same
20 manner as other State money may be invested.

21 (4) Expenditures from the Fund may only be made:

22 (i) pursuant to an appropriation approved by the General
23 Assembly in the annual State budget; or

24 (ii) by the budget amendment procedure provided for in § 7-209 of
25 this article, provided that:

26 1. the budget amendment and supporting information have
27 been submitted to the budget committees for their review and comment; and

28 2. at least 45 days have elapsed from the time the budget
29 amendment and supporting information were submitted to the budget committees.

30 [(d) The Board of Public Works shall designate the Department of Business
31 and Economic Development as the agency to administer the grant funding under this
32 section.]

33 [(e)] (D) The [Department of Business and Economic Development] COUNCIL
34 shall award grants on the basis of the BINDING recommendations of the Maryland
35 Agricultural Education and Rural Development Assistance Board.

1 [(f)] (E) (1) There is a Maryland Agricultural Education and Rural
2 Development Assistance Board.

3 (2) The Board shall consist of:

4 (i) the Secretary of Agriculture or the Secretary's designee;

5 (ii) the Secretary of Business and Economic Development or the
6 Secretary's designee;

7 (III) THE SECRETARY OF HOUSING AND COMMUNITY
8 DEVELOPMENT OR THE SECRETARY'S DESIGNEE;

9 (IV) THE SECRETARY OF HEALTH AND MENTAL HYGIENE OR THE
10 SECRETARY'S DESIGNEE;

11 [(iii)] (V) the Secretary of Natural Resources or the Secretary's
12 designee; and

13 [(iv)] (VI) the Chairman of the [Forvm for Rural Maryland]
14 COUNCIL or the Chairman's designee.

15 (3) THE AGENCIES LISTED IN SUBSECTION (E)(2)(I) THROUGH (V) OF THIS
16 SECTION MAY ASSIST THE COUNCIL WITH ADMINISTERING INDIVIDUAL GRANT
17 AWARDS.

18 [(3)] (4) The Board shall:

19 (i) establish procedures for applications for grants;

20 (ii) review applications for grants; and

21 (iii) make BINDING recommendations to the [Department of
22 Business and Economic Development] COUNCIL regarding the [recipient]
23 RECIPIENTS of grants and the amount of the grants.

24 [(4)] (5) [Beginning in fiscal year 2002, the] THE Board shall give
25 funding priority to organizations described in subsection (c)(2)(i) of this section that
26 have:

27 (i) obtained an equal matching amount of funding from a source
28 other than the State in the immediate prior fiscal year; or

29 (ii) sufficient evidence of a commitment of a third party funding
30 source to provide an equal matching amount of funding in the current fiscal year.

31 [(g)] (F) (1) A grant recipient shall submit to the [Department of Business
32 and Economic Development] COUNCIL written documentation of how the grant
33 recipient spent or otherwise used the grant.

1 (2) On or before June 30 of each year, the [Department of Business and
2 Economic Development] COUNCIL shall submit to the Governor and, in accordance
3 with § 2-1246 of the State Government Article, the General Assembly, a written
4 report that includes:

- 5 (i) the number of grants made during the fiscal year;
- 6 (ii) the names of the recipients of the grants;
- 7 (iii) the specific purpose of each grant awarded; and
- 8 (iv) documentation of how the grant recipient spent or otherwise
9 used the grant.

10 11-203.

11 (a) Except as provided in subsection (b) of this section, this Division II does
12 not apply to:

13 (1) procurement by:

- 14 (i) the Blind Industries and Services of Maryland;
- 15 (ii) the Maryland State Arts Council, for the support of the arts;
- 16 (iii) the Maryland Health and Higher Educational Facilities
17 Authority, if no State money is to be spent on a procurement contract;
- 18 (iv) the Maryland Higher Education Supplemental Loan Authority,
19 if no State money is to be spent on a procurement contract;
- 20 (v) the Maryland Industrial Training Program or the Partnership
21 for Workforce Quality Program in the Department of Business and Economic
22 Development, for training services or programs for new or expanding businesses or
23 industries or businesses or industries in transition;
- 24 (vi) the Maryland Food Center Authority, to the extent the
25 Authority is exempt under Title 13, Subtitle 1 of Article 41 of the Code;
- 26 (vii) the Maryland Public Broadcasting Commission, for services of
27 artists for educational and cultural television productions;
- 28 (viii) public institutions of higher education, for cultural,
29 entertainment, and intercollegiate athletic procurement contracts;
- 30 (ix) the Maryland State Planning Council on Developmental
31 Disabilities, for services to support demonstration, pilot, and training programs;
- 32 (x) the Maryland Automobile Insurance Fund;
- 33 (xi) the Maryland Historical Trust for:

1 1. surveying and evaluating architecturally, archeologically,
2 historically, or culturally significant properties; and

3 2. other than as to architectural services, preparing historic
4 preservation planning documents and educational material;

5 (xii) the University of Maryland, for University College Overseas
6 Programs, if the University adopts regulations that:

22 (2) A procurement by an entity listed in subsection (a)(1)(i) through (xv)
23 of this section shall be made under procedures that promote the purposes stated in §
24 11-201(a) of this subtitle.

25 (3) (i) A unit that procures human, social, or educational services from
26 an entity enumerated in subsection (a)(2) of this section shall publish in the Contract
27 Weekly notice of a procurement contract or an extension or renewal of a procurement
28 contract if:

1 (ii) The notice required under this paragraph shall be published not

9 (b) This subtitle does not apply to:

10 (1) a unit in the Legislative Branch of the State government;

11 (2) a unit in the Judicial Branch of the State government;

12 (3) the Injured Workers' Insurance Fund;

14 (5) the [Forvm for] Rural Maryland COUNCIL.

15 **Chapter 552 of the Acts of 2000**

16 SECTION 4. AND BE IT FURTHER ENACTED, That it is the intent of the
17 General Assembly that the Governor include in the annual State budget funds for the
18 [Forvm for] Rural Maryland COUNCIL in an amount equivalent to OR IN EXCESS OF
19 the [Forvm's] COUNCIL'S federal funding.

20 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take
21 effect July 1, 2000. [It shall remain effective for a period of 4 years and, at the end of
22 June 30, 2004, with no further action required by the General Assembly, this Act shall
23 be abrogated and of no further force and effect.]

24 **Chapter 534 of the Acts of 2002**

25 SECTION 2. AND BE IT FURTHER ENACTED, That:

26 (a) There is an Interagency Technical Assistance Committee on Wastewater
27 Treatment Systems.

28 (b) The Committee shall consist of at least 12 members, including
29 representatives appointed by each of the following agencies and organizations:

30 (1) the Department of Housing and Community Development;

31 (2) the Department of Planning;

- 1 (3) the Maryland Environmental Service;
- 2 (4) the [FORVM for] Rural Maryland COUNCIL;
- 3 (5) the Maryland Center for Environmental Training;

- 7 (9) the Maryland Association of Counties;
- 8 (10) the Maryland Rural Water Association;

- 10 (12) Safe Waterways in Maryland (SWIM).

11 (c) The members shall elect a chairman from among the members of the
12 Committee.

13 (d) The Department of the Environment shall provide staff for the Committee.

14 (e) A member may not receive compensation for serving on the Committee, but
15 is entitled to reimbursement for expenses under the Standard State Travel
16 Regulations, as provided in the State budget.

17 (f) The Committee shall implement a recommendation of the Governor's Task
18 Force on Upgrading Sewerage Systems by advising local jurisdictions on the efficient
19 operation and financial management of wastewater treatment systems.

20 (g) The Committee shall report to the State Advisory Council on Water
21 Security and Sewerage Systems on or before November 1 of each year.

22 SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the
23 General Assembly that the Department of Business and Economic Development
24 continue to administer the Maryland Agricultural Education and Rural Development
25 Assistance Fund for all grants made during Fiscal Year 2003, and earlier; and that
26 the Rural Maryland Council will begin administration of the Fund beginning in Fiscal
27 Year 2004, and continuing thereafter, by utilizing any appropriations that may have
28 been provided through the Board of Public Works for this purpose.

29 SECTION 3. AND BE IT FURTHER ENACTED, That any employee, who, as
30 of June 30, 2003, is assigned to the FORVM for Rural Maryland is hereby transferred
31 to the Rural Maryland Council, as established by Section 1 of this Act, effective July
32 1, 2003, without any change or loss of rights or status.

33 SECTION 4. AND BE IT FURTHER ENACTED, That, except as expressly
34 provided to the contrary in this Act, any transaction affected by or flowing from any

1 statute here amended, repealed, or transferred, and validly entered into before the
2 effective date of this Act and every right, duty, or interest following from it remains
3 valid after the effective date of this Act and may be terminated, completed,
4 consummated, or enforced pursuant to law.

5 SECTION 5. AND BE IT FURTHER ENACTED, That it is the intent of the
6 General Assembly that office furniture, computers, and other equipment, and
7 miscellaneous supplies that were purchased by the FORVM will transfer to the Rural
8 Maryland Council when its offices are relocated from Baltimore to Annapolis. The
9 affected State agencies are also directed to assist the FORVM and Rural Maryland
10 Council with their telecommunications and Internet website needs to insure that
11 services provided to the public are maintained with a minimum level of disruption.

12 SECTION 6. AND BE IT FURTHER ENACTED, That, except as otherwise
13 provided in this Act, all rules and regulations, proposed rules and regulations,
14 standards and guidelines, proposed standards and guidelines, orders and other
15 directives, forms, plans, memberships, special funds, appropriations, grants, loans,
16 applications and commitments for grants and loans, contracts, properties,
17 investigations, administrative and judicial proceedings, rights to sue and be sued, and
18 all other duties and responsibilities associated with those functions transferred by
19 this Act shall continue in effect until completed, withdrawn, canceled, modified, or
20 otherwise changed pursuant to law.

21 SECTION 7. AND BE IT FURTHER ENACTED, That if any provision of this
22 Act or the application thereof to any person or circumstance is held invalid for any
23 reason in a court of competent jurisdiction, the invalidity does not affect other
24 provisions or any other application of this Act which can be given effect without the
25 invalid provision or application, and for this purpose the provisions of this Act, are
26 declared severable.

27 SECTION 8. AND BE IT FURTHER ENACTED, That this Act shall take
28 effect July 1, 2003.
