1 A Senate Joint Resolution concerning

The AIDS Epidemic in Africa

3 FOR the purpose of urging the President and Congress of the United States of

4 America to encourage abstinence programs for preventing HIV/AIDS in Africa

5 <u>and</u> to advise pharmaceutical companies to take action to make available to

6 Africans infected with HIV and AIDS life-saving drugs at low cost.

7 WHEREAS, Governor Glendening stated in his State of the State 2002

8 address, "The anthrax attacks responsible for five deaths in the United States

9 generated a nationwide demand that pharmaceutical companies lower the cost of

10 antibiotics, yet there has been no global outery or demands made on pharmaceutical

11 companies in response to the millions of Africans who have died as a result of AIDS"

12 President George W. Bush in his 2003 State of the Union address stated that "on the

13 continent of Africa, nearly 30 million people have the AIDS virus, including 3 million

14 children under the age of 15. There are whole countries in Africa where more than

15 <u>one-third of the adult population carries the infection. More than 4 million require</u>

16 immediate drug treatment, yet across that continent, only 50,000 AIDS victims are

17 receiving the medicine they need"; and

18 WHEREAS, Africans account for 70% of the adults and 80% of the children 19 living with HIV in the world, and roughly 28.1 million adults and children with 20 HIV/AIDS live in Africa; and

21 WHEREAS, AIDS deaths in Africa totaled 2.3 million in 2001 while the global 22 total was 3 million, and the 21 countries with the highest rates of HIV prevalence are 23 located in Africa; and

24 WHEREAS, African countries have to confront the obstacles of providing 25 health care for the growing population with HIV/AIDS, preventing uninfected

Africans from becoming infected with HIV, and coping with the effects of millions of
AIDS deaths on the economy; and

3 <u>WHEREAS</u>, Abstinence programs have had a dramatic effect in stemming the 4 increase in the HIV/AIDS incidence in Uganda; and

5 WHEREAS, Because the African AIDS epidemic will impact the worldwide 6 economic, social, and political organizations, the rest of the world cannot afford to 7 ignore Africa's situation; now, therefore, be it

8 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That the State 9 of Maryland urges the President of the United States and the Congress of the United

10 States of America to encourage the use of abstinence programs whenever feasible and

11 to advise pharmaceutical companies to take every conceivable action to make

12 available to Africans infected with HIV and AIDS life-saving drugs at low cost to

13 stem the tide of the AIDS epidemic; and be it further
