1 A Senate Joint Resolution concerning

## 2 Support of the U.S. Armed Forces and in their Liberation of the Iraqi People

- 3 FOR the purpose of supporting the U.S. Armed Forces and in their liberation of the
- 4 Iraqi people; supporting the families of the U.S. Armed Forces; supporting the
- 5 enforcement of Resolution 1441; and generally relating to support of the U.S.
- 6 Armed Forces and in their liberation of the Iraqi people.
- WHEREAS, Since 1991, the United States and the United Nations have worked
- 8 in accordance to numerous UN resolutions to peacefully disarm Saddam Hussein and
- 9 the Iraqi government; and
- WHEREAS, Hussein has deliberately flouted the will of and been a threat to the
- 11 world community and his own people; and
- WHEREAS, In September 2002, both houses of the U.S. Congress authorized
- 13 the President of the United States to use force in enforcing the numerous United
- 14 Nations resolutions against Hussein and the Iraqi government; and
- WHEREAS, In November 2002, the United Nations Security Council passed
- 16 Resolution 1441 unanimously declaring Iraq in material breach of its obligations and
- 17 vowing serious consequences if Iraq did not fully and immediately disarm; and

- 1 WHEREAS, President George W. Bush has ordered military action against the
- 2 Iraqi government to uphold Resolution 1441 and the numerous resolutions requiring
- 3 Iraq to disarm; and
- 4 WHEREAS, Men and women from Maryland have been called to active duty
- 5 joining hundreds of thousands of military personnel from across the United States
- 6 and other allied nations to protect our nation and our world from the threat of
- 7 Hussein and the Iraqi government; and
- 8 WHEREAS. The families of these brave soldiers provide support to them and
- 9 remind us of the bravery and importance of our armed forces; now, therefore, be it
- WHEREAS, The United States and its coalition partners are presently engaged
- 11 in a conflict in Iraq; and
- 12 WHEREAS, The Maryland General Assembly honors the bravery and courage of
- 13 the men and women from Maryland who have been called to active duty joining
- 14 hundreds of thousands of military personnel from across the United States and other
- 15 allied nations to protect our nation and our world from the threat of Hussein and the
- 16 Iraqi government; and
- WHEREAS, The Maryland General Assembly joins the families of these brave
- 18 troops in wishing them well in combat and prays for their quick return after a
- 19 well-fought victory; now, therefore, be it
- 20 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That the
- 21 General Assembly of Maryland offers its strong support for liberating Iraq and
- 22 enforcing the will of Resolution 1441 the liberators of Iraq; and be it further

- 25 their patriotic duty with bravery and professionalism; and be it further
