Ways and Means

Higher Education - Community Colleges - State Funding

This bill restores full State funding for community colleges by fiscal 2005 instead of 2006.

The bill is effective July 1, 2003.

Fiscal Summary

State Effect: General fund expenditures would increase by an estimated \$7.3 million in FY 2005 to enhance funding for community colleges. There is no effect after FY 2005.

Local Effect: Community college revenues from State aid would increase by \$7.3 million in FY 2005.

Small Business Effect: None.

Analysis

Current Law: Full funding for the formula that determines the State appropriation for Baltimore City Community College and the Senator John A. Cade Funding Formula, which determines State aid for the other 15 community colleges in Maryland, will be restored in fiscal 2006.

Background: State funding for community colleges was reduced in fiscal 2003 due to the fiscal crisis. To enact the reduction, the formulas that determine State funding were adjusted downwards and were positioned to rebound to their full funding levels by fiscal 2006.

Mandated fiscal 2004 funding for community colleges through the Senator John A. Cade formula was initially calculated at \$162 million. However, this amount will be reduced by \$9.7 million contingent upon a proposed reduction in fiscal 2003 State funding for public four-year institutions of higher education. The Cade formula is based on the prior year funding for the public four-year institutions, so a fiscal 2003 reduction in funding for four-year institutions impacts the fiscal 2004 funding for community colleges.

State and Local Fiscal Effect: State general fund support for community colleges would increase in fiscal 2005 by an estimated \$7.3 million. The increase for each of the community colleges is shown in **Exhibit 1**. Full State funding will be restored in fiscal 2006 under current law, so this legislation would only impact fiscal 2005.
