## Task Force to Study Veterans and Their Impact on the State

This bill establishes a Task Force to Study Veterans and Their Impact on the State to review the fiscal impact of veterans leaving the State for more advantageous situations; the cost of health care paid by the State for veterans; the cost of losing volunteers in the State who are veterans; and the cost, as they relate to veterans, of maintaining homeless programs, alcohol- and drug-related programs, and out-of-state care costs. The Governor must appoint task force members with the advice of the Secretary of Veterans Affairs. Task force members cannot receive compensation but are entitled to expense reimbursements. The task force must report its findings to the Governor and the General Assembly on or before October 1, 2004. The Department of Veterans Affairs is required to provide staff support for the task force.

The bill is effective July 1, 2003 and sunsets October 31, 2004.

# **Fiscal Summary**

**State Effect:** None. Any expense reimbursements for the task force members and staffing costs for the Department of Veterans Affairs are assumed to be minimal and absorbable within existing budgeted resources.

## **Analysis**

**Background:** According to the U.S. Department of Veterans Affairs, there are approximately 493,000 veterans living in Maryland. **Exhibit 1** shows the number of veterans by period of service, and **Exhibit 2** shows the amount of federal expenditures provided to veterans in fiscal 2001 by county.
