"(2) THE NOTICE REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL STATE ALL APPLICABLE REASONS FOR THE DEPARTMENT'S ACTION.";

in line 29, after "shall" insert ", BEFORE PUBLICATION, DELIVER TO THE JOINT COMMITTEE ON ADMINISTRATIVE, EXECUTIVE, AND LEGISLATIVE REVIEW A NOTICE OF INTENT TO CLOSE AN AREA OF A NATURAL OYSTER BAR, INCLUDING ALL APPLICABLE REASONS FOR THE DEPARTMENT'S ACT, AND"; in the same line, strike "a" and substitute "<u>THE</u>"; and in lines 29 and 30, strike "of intent to close any area of a natural oyster bar".

On page 6, in line 14, after "shall" insert ", BEFORE PUBLICATION, DELIVER A NOTICE OF RESERVATION, INCLUDING ALL APPLICABLE REASONS FOR THE DEPARTMENT'S ACT, TO THE JOINT COMMITTEE ON ADMINISTRATIVE, EXECUTIVE, AND LEGISLATIVE REVIEW AND"; in the same line, strike "a" and substitute "THE"; in the same line, strike "of reservation"; and in line 16, strike "of the State" and substitute "IN WHICH THE AFFECTED WATERS ARE LOCATED, AND ON THE WEBSITE OF THE DEPARTMENT".
