AMENDMENTS TO SENATE BILL NO. 320, AS AMENDED

(Third Reading File Bill)

AMENDMENT NO. 1

On page 1 of the bill, in lines 12 and 13, strike ", onsite sewage disposal systems, and sewage holding tanks,".

On page 1 of the Environmental Matters Committee Amendments (SB0320/190615/1), in lines 14 and 15 of Amendment No. 1, strike "<u>requiring the Department to jointly report to certain</u> legislative committees on or before a certain date;".

AMENDMENT NO. 2

On page 11 of the Environmental Matters Committee Amendments, strike beginning with ";" in line 2 of Amendment No. 2 down through "<u>TANK</u>" in line 4.

On page 7 of the bill, in lines 20 and 21, strike "<u>, AN ONSITE SEWAGE DISPOSAL SYSTEM</u>, OR A HOLDING TANK"; and strike beginning with "BEGINNING" in line 29 down through "(IV)" in line 33.

On page 11 of the Environmental Matters Committee Amendments, in lines 7 and 8 of Amendment No. 2, strike "AND EACH USER OF AN ONSITE SEWAGE DISPOSAL SYSTEM OR HOLDING TANK THAT RECEIVES A WATER BILL"; in line 9, strike "OCTOBER"; in lines 10 and 11, strike "THAT DOES NOT RECEIVE A WATER BILL, \$30 PER YEAR"; in lines 13 and 14, strike "A USER OF AN ONSITE SEWAGE DISPOSAL SYSTEM OR A HOLDING TANK THAT RECEIVES A WATER BILL,"; in lines 17 and 18, strike "1. A. IF THE USER DOES NOT RECEIVE A WATER BILL,"; strike beginning with "THE" in line 18 down through "COLLECTING" in line 20; and strike beginning with "B." in line 22 down through "SHALL" in line 27.

On page 12 of the Environmental Matters Committee Amendments, strike beginning with

"<u>DETERMINE</u>" in line 1 of Amendment No. 2 down through "<u>SUBPARAGRAPH.</u>" in line 2. On page 7 of the bill, in line 28, after ";" insert "<u>AND</u>".

On page 8 of the bill, in line 13, strike "(I)".

On page 10 of the bill, in lines 14 and 15, strike "<u>, AN ONSITE SEWAGE DISPOSAL</u> SYSTEM BILL, OR A HOLDING TANK BILL".

On pages 12 and 13 of the bill, strike beginning with "(1)" in line 27 on page 12 down through "ACTIVITIES." in line 3 on page 3.

On page 12 of the Environmental Matters Committee Amendments, in line 14 of Amendment No. 2, strike "<u>AND (III)</u>"; in lines 15 and 16, strike "<u>DISBURSE THE FUNDS AS PROVIDED UNDER PARAGRAPH (2) OF THIS SUBSECTION.</u>"; and strike beginning with "<u>(2)</u>" in line 17 down through "<u>OR</u>" in line 25.

On page 13 of the Environmental Matters Committee Amendments, strike beginning with "<u>B.</u>" in line 1 down through "<u>AND</u>" in line 18; in line 19, strike "(<u>II)</u>"; in line 20, strike "<u>40%</u>"; and in the same line, strike "(<u>3)</u>".

On page 13 of the bill, strike "(I)", "(II)", "(III)", and "(IV)", respectively, and substitute "(1)", "(2)", "(3)", and "(4)", respectively.

On page 14 of the bill, in line 19, after the semicolon, insert "AND"; and strike beginning with "; AND" in line 21 down through "ACTIVITIES" in line 24.

On page 14 of the Environmental Matters Committee Amendments, strike beginning with "IN" in line 1 of Amendment No. 2 down through "(VIII)" in line 17; and in line 18, strike "(IX)" and substitute "(VI)".

On page 20 of the bill, strike beginning with "<u>AND</u>" in line 3 down through "<u>4.</u>" and in line 11; in line 20, strike "<u>5.</u>" and substitute "<u>4.</u>".

On page 14 of the Environmental Matters Committee Amendments' in lines 21 and 22, strike ", in consultation with the governing body of each county,"; in line 22, strike "by local governments"; and in line 23, strike "that do not receive water bills".

On pages 14 and 15 of the Environmental Matters Committee Amendments, strike beginning
