On page 2, in line 1, strike "requiring the Board of Regents to submit a certain report;"; in line 3, after "University" insert "and St. Mary's College of Maryland"; strike beginning with "is" in line 5 down through "unit" in line 6 and substitute "and St. Mary's College of Maryland are units"; strike beginning with "exempting" in line 6 down through "reversion;" in line 10; strike beginning with "specifying" in line 18 down through "subtitle;" in line 20; in line 26, strike "14-102(a) through (e) and"; in line 27, strike "14-102(b) through (f) and"; strike in their entirety lines 30 through 34, inclusive; and strike line 37 in its entirety and substitute "Section 14-101 and 14-104(a)".

On page 3, strike line 6 in its entirety and substitute "Section 14-104(b) and (p) and 14-109"; in lines 11 and 12, strike "4-402(a), 4-406(a) and (b), 5-7B-01(d)(1)(v), 7-306(a),"; in line 12, strike "12-202, and 14-202(a)" and substitute "and 12-202"; in line 16, strike "14-102(a) through (e) and"; after line 14, insert:

"BY repealing and reenacting, without amendments,

Article - State Finance and Procurement Section 4-402(a), 4-406(a) and (b), 5-7B-01(d)(1)(v), and 7-306(a) Annotated Code of Maryland (2001 Replacement Volume and 2003 Supplement)"; and in line 18, strike "14-102(b) through (f) and".

AMENDMENT NO. 2

On pages 3 through 4, strike in their entirety the lines beginning with line 25 on page 3 through line 8 on page 4, inclusive.

AMENDMENT NO. 3

On page 4, strike in their entirety lines 24 through 32, inclusive.

On page 5, strike beginning with "IN" in line 14 down through "(6)" in line 27.

On page 6, after line 29, insert:

"(6) (I) <u>SUBJECT TO THE APPROVAL OF THE BOARD OF PUBLIC</u> WORKS, THE BOARD MAY ACQUIRE, LEASE, ENCUMBER, SELL, OR OTHERWISE DISPOSE OF REAL PROPERTY HELD BY THE STATE FOR THE USE OF THE UNIVERSITY.

(II) THE BOARD MAY ACQUIRE, LEASE, ENCUMBER, SELL, OR OTHERWISE DISPOSE OF PERSONAL PROPERTY.

(III) <u>ALL PROPERTY OF THE UNIVERSITY IS THE PROPERTY OF</u> <u>THE STATE.</u>".

On page 7, strike in their entirety lines 12 through 35, inclusive.

AMENDMENT NO. 4

On page 3, strike in their entirety lines 19 through 21, inclusive; and in line 22, strike "3." and substitute "2.".

On page 8, in lines 18 and 29, in each instance, after "Maryland" insert "<u>, ST. MARY'S</u> <u>COLLEGE OF MARYLAND</u>,".

On page 9, in line 11, strike the brackets; strike beginning with the semicolon in line 12 down through "UNIVERSITY" in line 13; in line 14, strike the brackets; in the same line, strike the second "4-406"; in lines 15 and 16, strike the brackets; in line 16, strike "IS"; in line 18, strike the brackets; in the same line, strike the brackets.

On page 10, strike beginning with "OR" in line 1 down through "UNIVERSITY" in line 2; in line 3, strike the brackets; in the same line, strike "§ 4-410.1"; in line 15, strike the brackets; in line

AMENDMENT NO. 5

in line 6, after "1999" insert "; AND

2. MORGAN STATE UNIVERSITY BEFORE JULY 1, 2004";

in line 7, strike "A UNIVERSITY" and substitute "<u>THE UNIVERSITY SYSTEM OF</u> <u>MARYLAND</u>"; and after line 10, insert:

"(III) AT THE ELECTION OF THE BOARD OF REGENTS OF MORGAN STATE UNIVERSITY AND SUBJECT TO THE APPROVAL OF THE BOARD OF PUBLIC WORKS, THE STATE BOARD OF CONTRACT APPEALS SHALL HAVE AUTHORITY OVER CONTRACT CLAIMS RELATED TO PROCUREMENT CONTRACTS AWARDED BY THE UNIVERSITY AFTER JUNE 30, 2004.".

AMENDMENT NO. 6

On page 14, strike in their entirety lines 2 through 11, inclusive; in line 12, strike "4." and substitute "<u>3.</u>"; and in line 18, strike "5." and substitute "<u>4.</u>".
