## AMENDMENT NO. 1

On page 1, in the sponsor line, strike "Senator Pinsky" and substitute "Senators Pinsky, Forehand, and Haines".

## AMENDMENT NO. 2

On page 1, in line 4, after "solicit" insert "or accept"; in line 13, after "provisions;" insert "exempting certain charitable organizations that are licensed as wholesale vehicle dealers from the annual license fee; requiring certain charitable organizations that are licensed as wholesale vehicle dealers and accept more than a certain number of vehicle donations to pay a certain license fee;"; and in line 14 , after "accepting" insert "a certain number of".

On page 2, in line 8, after "15-101(b)" insert "and 15-307".

## AMENDMENT NO. 3

On page 3, in line 3, strike "THE APPLICABLE PROVISIONS OF"; and in line 12, strike " 1 " and substitute " 13 ".

On page 6, in line 22, strike "SUBSECTION (A) OF".

On page 8 , in line 18 , strike " 1 " and substitute " 13 ".

## AMENDMENT NO. 4

On page 3, in line 5, after "THAT" insert ", DURING ANY 12-MONTH PERIOD,"; in the same line, after "ACCEPTS" insert "THREE OR"; in the same line, strike "THAN 25"; strike beginning with "DURING" in line 6 down through "VEHICLES," in line 7 and substitute "FOR RESALE PURPOSES"; and in line 7, strike "THE PROVISIONS OF".

## Page 2 of 2

On page 7, in line 3, strike "ACCEPTS MORE THAN 25 VEHICLE DONATIONS" and substitute a comma; and in line 4, strike "THE OWNERSHIP OF WHICH WAS ACQUIRED" and substitute "ACCEPTS THREE OR MORE VEHICLE DONATIONS".

On page 8 , in line 4 , after the semicolon insert "OR"; and strike beginning with the semicolon in line 8 down through "RESALE" in line 12.

## AMENDMENT NO. 5

On page 8 , after line 12 , insert:
"15-307.
(a) Each licensed dealer shall pay to the Administration an annual license fee established by the Administration for each license year or part of a license year for which the license is issued.
(b) A licensed dealer need not pay more than one annual fee, regardless of the number of its business locations.
(c) On payment of the fee required by this section and issuance of a dealer's license, the Administration also shall issue one vehicle salesman's license without further charge.
(D) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A RELIGIOUS, CHARITABLE, OR VOLUNTEER ORGANIZATION EXEMPT FROM TAXATION UNDER § 501(C) OF THE INTERNAL REVENUE CODE THAT IS LICENSED UNDER § 15-305.1 OF THIS SUBTITLE AND ACCEPTS 25 OR FEWER VEHICLE DONATIONS WITHIN A LICENSE YEAR IS EXEMPT FROM THE ANNUAL LICENSE FEE.
(2) IF A RELIGIOUS, CHARITABLE, OR VOLUNTEER ORGANIZATION DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION ACCEPTS MORE THAN 25 VEHICLE DONATIONS IN ANY LICENSE YEAR OF A 2-YEAR LICENSE PERIOD, THE ORGANIZATION SHALL PAY THE FEE REQUIRED BY THE ADMINISTRATION FOR A 2-YEAR LICENSE.".
