AMENDMENTS TO HOUSE BILL NO. 1471 (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in lines 2, 3, 14, 18, and 26, in each instance, strike "Dredge" and substitute "<u>Dredged</u>"; in lines 5 and 12, in each instance, after "Department" insert "<u>of Business and Economic</u> <u>Development</u>"; in line 7, strike "a certain percentage of the"; in line 8, strike "Port Administration for certain uses" and substitute "<u>Department of Transportation; requiring the Maryland Department of Transportation to allocate certain money appropriated to it after certain conditions are met"; in line 13, after "Program;" insert "requiring, on or before a certain date, the Maryland Department of <u>Transportation to submit a certain report to certain persons;</u>"; and in line 10, strike "dredge" and substitute "<u>dredged</u>".</u>

AMENDMENT NO. 2

On page 2, in lines 7 and 9, in each instance, strike "dredge" and substitute "<u>dredged</u>"; and in lines 14, 18, 21, 22, 24, 28, 31, and 32, in each instance, strike "DREDGE" and substitute "<u>DREDGED</u>".

On page 3, in lines 2, 4, 5, 6, 9, 10, 12, 18, 20, 21, 33, and 34, in each instance, strike "DREDGE" and substitute "<u>DREDGED</u>"; in line 28, after "(F)" insert "(1)"; in line 28, strike "TO THE PROGRAM"; in line 29, strike "5% OF THE"; and in line 30, strike "MARYLAND PORT ADMINISTRATION FOR THE MANAGEMENT OF DREDGE MATERIAL" and substitute "<u>MARYLAND DEPARTMENT OF TRANSPORTATION</u>.

(2) THE MARYLAND DEPARTMENT OF TRANSPORTATION SHALL, IN ACCORDANCE WITH THE ANNUAL STATE BUDGET, ALLOCATE MONEY FROM THE TRANSPORTATION TRUST FUND FOR THE PROGRAM AFTER ELEMENTS OF A LONG-TERM PLAN FOR MANAGING DREDGED MATERIAL ARE OPERATIONAL AND PROVIDE 20 YEARS OF PLACEMENT CAPACITY AS DEFINED IN §§ 5-1102(D)(2)(II) AND 5-1104.2(D) OF THE ENVIRONMENT ARTICLE".

On page 4, in line 1, after "That" insert "<u>, on or before October 1, 2006, the Maryland</u> <u>Department of Transportation shall report to the Governor and, subject to § 2-1246 of the State</u> <u>Government Article, the General Assembly on the planned date of funding of the Dredged Material</u> <u>Disposal Alternatives Program.</u>

SECTION 3. AND BE IT FURTHER ENACTED, That";

in lines 2 and 10, in each instance, strike "Dredge" and substitute "<u>Dredged</u>"; in lines 4 and 7, in each instance, strike "dredge" and substitute "<u>dredged</u>"; and in lines 8 and 12, strike "3." and "4.", respectively, and substitute "<u>4.</u>" and "<u>5.</u>", respectively.
