AMENDMENTS TO SENATE BILL NO. 83

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, strike “- Child Safety Zone”; in line 4, strike “requiring” and substitute “authorizing”; in the same line, strike “a certain child safety zone” and substitute “certain conditions of probation”; in line 6, after “crimes” insert “involving a victim who is a minor”; strike beginning with “setting” in line 6 down through “zone;” in line 7; in lines 7 and 8, strike “the required elements of a child safety zone” and substitute “certain conditions of probation”; in line 9, strike “the child safety zone” and substitute “certain conditions of probation”; and in line 10, strike “child safety zones” and substitute “certain conditions of probation”.

AMENDMENT NO. 2

On page 4, strike beginning with “IF” in line 11 down through “SEXUALLY,” in line 12; in line 13, after “ARTICLE” insert “, WITH THE INTENT TO VIOLATE § 3-303, § 3-304, § 3-305, § 3-306, OR § 3-307 OF THE CRIMINAL LAW ARTICLE”; strike beginning with “IF” in line 15 down through “WAS” in line 16 and substitute “INVOLVING”; strike beginning with “IF” in line 17 down through “SEXUALLY,” in line 18; in line 19, after “IMPRISONMENT” insert “, WITH THE INTENT TO VIOLATE § 3-303, § 3-304, § 3-305, § 3-306, OR § 3-307 OF THE CRIMINAL LAW ARTICLE”; strike beginning with “SHALL” in line 22 down through “THAT” in line 23 and substitute “MAY,”; in line 24, strike “PROHIBITS” and substitute “PROHIBIT”; in line 28, strike “ENTERING OR BEING” and substitute “LOITERING”; in line 29, strike “WHERE MINORS COMMONLY GATHER” and substitute “USED BY A VICTIM OF THE DEFENDANT OR PRIMARILY USED BY MINORS”; and in line 32, strike “REQUIRES” and substitute “REQUIRE”.

On page 5, strike beginning with “IN” in line 1 down through the comma in line 2; strike beginning with “AFTER” in line 6 down through “SECTION” in line 7 and substitute “, ON MOTION OF THE DEFENDANT”; in line 11, strike the first “OR” and substitute a comma; and in the same line, after “EMPLOYMENT” insert “, OR MAINTAIN FAMILY RELATIONSHIPS WHEN THERE IS NO LIKELIHOOD OF THE DEFENDANT COMMITTING A SEXUAL OFFENSE WITH A FAMILY MEMBER WHO IS A MINOR”.
