AMENDMENT NO. 1

On page 1, in line 2, strike "Computers - Internet Auction Fraud" and substitute "<u>Theft - Use</u> <u>of Interactive Computer Service</u>"; strike beginning with "establishing" in line 3 down through the semicolon in line 6; in line 7, after "crime" insert "<u>of theft by use of an interactive computer</u> <u>service</u>"; strike beginning with "requiring" in line 7 down through the first semicolon in line 10; in the same line, strike "certain terms" and substitute "<u>a certain term</u>"; in line 11, strike "Internet auction listing" and substitute "<u>interactive computer</u>"; and in the same line, strike "or fraud".

AMENDMENT NO. 2

On page 1, after line 11, insert:

"BY renumbering

Article - Criminal Law Section 7-101(e) through (m), respectively to be Section 7-101(f) through (n), respectively Annotated Code of Maryland (2002 Volume and 2003 Supplement)".

On page 1, in line 14, strike "8-409" and substitute "<u>7-101(e) and 7-104(j)</u>"; and in line 18, after "MARYLAND," insert "<u>That, Section(s) 7-101(e) through (m), respectively, of Article -</u> <u>Criminal Law of the Annotated Code of Maryland be renumbered to be Section(s) 7-101(f) through</u> (n), respectively.

AMENDMENT NO. 3

On pages 1 and 2, strike in their entirety the lines beginning with line 20 on page 1 through

in line 25, strike "(D)" and substitute "<u>(J)</u>"; in line 25, after "SECTION" insert "<u>BY USE OF AN</u> <u>INTERACTIVE COMPUTER SERVICE</u>"; and in line 26, after "WHICH" insert "<u>THE VICTIM</u> <u>RESIDES OR</u>".

On pages 2 and 3, strike in their entirety the lines beginning with line 28 on page 2 through line 7 on page 3, inclusive.

On page 3, in line 8, strike "2." and substitute "<u>3.</u>".
