AMENDMENTS TO HOUSE BILL NO. 1414 (First Reading File Bill)

AMENDMENT NO. 1

On page 2, in line 3, strike the brackets; in the same line, strike the first comma; strike beginning with ", AND" in line 3 down through "FUND" in line 4; and strike beginning with "MAY" in line 12 down through "FUND" in line 14 and substitute "<u>SHALL BE CREDITED TO</u> <u>THE GENERAL FUND OF THE STATE</u>".

AMENDMENT NO. 2

On page 3, strike beginning with "THE" in line 17 down through the second "FUND" in line 20 and substitute "<u>ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED TO</u> <u>THE GENERAL FUND OF THE STATE. ANY UNSPENT PORTIONS OF THE FUND AT THE</u> <u>END OF A FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF THE STATE</u>".

AMENDMENT NO. 3

On page 7, in lines 23 and 24, strike ": (I) ANY" and substitute "<u>ANY</u>"; and strike beginning with the semicolon in line 25 down through "FUND" in line 26.

On page 8, strike beginning with "MAY" in line 19 down through "REVERT" in line 20 and substitute "<u>SHALL BE CREDITED</u>"; and strike beginning with ", BUT" in line 20 down through "FUND" in line 21.

AMENDMENT NO. 4

On page 8, strike beginning with "REVENUES" in line 37 down through "REVERT" in line 40 and substitute "<u>ANY INVESTMENT EARNINGS DERIVED FROM THE REVENUES SHALL</u> <u>BE CREDITED</u>"; and in line 40, after "STATE." insert "<u>ANY UNSPENT PORTIONS OF THE</u> <u>FUND AT THE END OF A FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF</u> <u>THE STATE.</u>".

AMENDMENT NO. 5

On page 9, strike beginning with "(1)" in line 13 down through "(2)" in line 15; in line 22, after the semicolon insert "<u>AND</u>"; and strike beginning with the semicolon in line 24 down through "FUND" in line 25.

On page 10, strike beginning with "MAY" in line 12 down through "FUND" in line 14 and substitute "<u>SHALL BE CREDITED TO THE GENERAL FUND OF THE STATE</u>"; and after line 16, insert:

"(J) ANY UNSPENT PORTIONS OF THE FUND AT THE END OF A FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF THE STATE.".

AMENDMENT NO. 6

On page 11, strike beginning with "(1)" in line 8 down through "(2)" in line 10; and in line 14, strike "AND ANY INVESTMENT EARNINGS OF THE ACCOUNT".

On page 12, in line 5, strike "(1)"; strike in their entirety lines 7 through 9, inclusive; and after line 14, insert:

"(J) ANY UNSPENT PORTIONS OF THE FUND AT THE END OF A FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF THE STATE.".

AMENDMENT NO. 7

On page 13, in line 31, strike the brackets; and strike beginning with the semicolon in line 33 down through "FUND" in line 34.

On page 14, strike beginning with "MAY" in line 8 down through "FUND" in line 10 and substitute "<u>SHALL BE CREDITED TO THE GENERAL FUND OF THE STATE</u>"; and after line 12, insert:

"(J) ANY UNSPENT PORTIONS OF THE FUND AT THE END OF A FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF THE STATE.".

AMENDMENT NO. 8

On page 15, strike in their entirety lines 10 and 11 and substitute:

"(C) (1) ANY UNSPENT PORTIONS OF THE FUND AT THE END OF A FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF THE STATE.";

strike beginning with "MAY" in line 12 down through "REVERT" in line 13 and substitute "<u>SHALL</u> <u>BE CREDITED</u>"; and strike beginning with ", BUT" in line 13 down through "FUND" in line 14.

AMENDMENT NO. 9

On page 15, strike beginning with ", AND" in line 27 down through "FUND," in line 28.

On page 16, strike beginning with "MAY" in line 5 down through "REVERT" in line 6 and substitute "<u>SHALL BE CREDITED</u>"; and strike beginning with ", BUT" in line 6 down through "FUND" in line 7.

On page 17, in line 2, strike beginning with "MAY" through "REVERT" and substitute "<u>SHALL BE CREDITED</u>"; in line 3, strike beginning with ", BUT" through the second "FUND"; and strike beginning with ", AND" in line 22 down through "FUND," in line 23.

AMENDMENT NO. 10

On page 18, strike beginning with "THE" in line 3 down through "(2)" in line 5; in line 7, strike "(3)" and substitute "(2)"; strike beginning with "ANY" in line 13 down through "(3)" in line 14; in line 15, strike "(4)" and substitute "(3)"; after line 20, insert:

"(<u>G</u>) <u>ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED TO</u> <u>THE GENERAL FUND OF THE STATE.</u>";

in lines 21 and 26, strike "(G)" and "(H)", respectively, and substitute "(H)" and "(I)", respectively; and after line 27, insert:

"(J) ANY UNSPENT PORTIONS OF THE FUND AT THE END OF A FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF THE STATE.".

AMENDMENT NO. 11

On page 19, in line 5, strike the brackets; strike beginning with "ANY" in line 6 down through "(IV)" in line 7; strike in their entirety lines 10 and 11 and substitute:

"(2) (I) <u>ANY UNSPENT PORTIONS OF THE FUND AT THE END OF A</u> FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF THE STATE.";

strike beginning with "MAY" in line 12 down through "REVERT" in line 13 and substitute "<u>SHALL</u> <u>BE CREDITED</u>"; and strike beginning with ", BUT" in line 13 down through "FUND" in line 14.

On page 21, after line 2, insert:

"(H) ANY UNSPENT PORTIONS OF THE FUND AT THE END OF A FISCAL YEAR SHALL REVERT TO THE GENERAL FUND OF THE STATE.".
