## AMENDMENTS TO HOUSE BILL NO. 1414

(Third Reading File Bill)

### AMENDMENT NO. 1

On page 1, in line 3, after "Accounts" insert "and Management of Leased Properties"; and in line 12, after "Fund;" insert "requiring the Department to renew certain leases for a certain time and under certain circumstances;".

#### AMENDMENT NO. 2

On page 3, strike beginning with "<u>ANY</u>" in line 28 down through "<u>STATE</u>" in line 29 and substitute "<u>THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT SUBJECT TO §</u> 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE".

On page 9, strike beginning with "<u>ANY</u>" in line 8 down through "<u>STATE</u>" in line 10 and substitute "<u>REVENUES FROM THE FEE ARE NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE</u>"; in line 26, before "THE" insert "(1)"; and after line 27, insert:

"(2) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.".

On page 10, strike in their entirety lines 28 and 29.

On page 11, in line 19, before the first "THE" insert "(1)"; and in line 20, after "ACCOUNT." insert:

"(2) THE ACCOUNT IS A SPECIAL, NONLAPSING ACCOUNT THAT IS NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.".

On page 12, in line 17, before the first "THE" insert "(1)"; and after line 18, insert:

# "(2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED TO THE GENERAL FUND OF THE STATE.";

and strike in their entirety lines 27 and 28.

### AMENDMENT NO. 3

On page 14, strike in their entirety lines 26 and 27.

On page 15, strike beginning with "<u>ANY</u>" in line 27 down through "<u>STATE.</u>" in line 28 and substitute "<u>THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT SUBJECT TO §</u> 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.".

On page 17, in line 17 strike "(I)"; and strike in their entirety lines 21 through 24, inclusive.

On page 18, after line 26, insert:

"(3) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.".

On page 19, strike in their entirety lines 14 and 15; and strike beginning with "<u>ANY</u>" in line 34 down through "<u>STATE</u>." in line 35 and substitute "<u>THE FUND IS A SPECIAL</u>, <u>NONLAPSING FUND THAT IS NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.</u>".

On page 21, strike in their entirety lines 27 and 28.

# AMENDMENT NO. 4

On page 23, after line 35, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That, until the Department of Natural Resources has formally adopted policies and guidelines for the leasing of property in State parks in accordance with regular Departmental procedures for the adoption of policies and guidelines, at the request of a current lessee who is in compliance with the lease agreement, the Department shall on an annual basis renew a current lease."

On page 24, in line 1, strike "2." and substitute "3.".
