AMENDMENTS TO HOUSE BILL NO. 626 (Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 6, after "Program;" insert "<u>authorizing a Program participant to provide</u> <u>door-to-door transportation to an eligible senior who does not reside in a certain geographic area</u> <u>under certain circumstances; requiring a Program participant to expend a certain matching fund;</u> <u>establishing certain limitations on the number and amount of grants that may be awarded under the</u> <u>Program; authorizing a Program participant to charge a certain fee;</u>"; in the same line, strike "parties" and substitute "<u>persons</u>"; in line 8, strike "authorizing grant participants to provide" and substitute "<u>establishing that this Act does not prohibit a Program participant from providing</u>"; and in line 10, after "Administration;" insert "<u>defining certain terms;</u>".

On page 3, in line 8, strike "A GRANT" and substitute "<u>GRANTS</u>"; in line 19, after "FOR" insert "<u>DOOR-TO-DOOR</u>"; and in lines 19 and 20, strike "TO AND FROM APPOINTMENTS".

On page 3 in line 31, and on page 4 in line 31, in each instance, strike "SERVICES".

On page 4, in line 2, strike "PROGRAM" and substitute "<u>ADMINISTRATION</u>"; and in lines 10 and 11 and 19, in each instance, strike "PROVIDING TRANSPORTATION SERVICES" and substitute "<u>TO PROVIDE DOOR-TO-DOOR TRANSPORTATION</u>".

On page 5, in line 21, strike "TRANSPORTATION SERVICES" and substitute "DOOR-TO-DOOR TRANSPORTATION".

AMENDMENT NO. 2

On page 3, in line 33, after "(G)" insert "(1)"; after line 34, insert:

"(2) THE ADMINISTRATION MAY NOT AWARD MORE THAN \$400,000 IN

(Over)

GRANTS PER YEAR.

(H) <u>A PROGRAM PARTICIPANT MAY CHARGE REASONABLE FEES FOR</u> DOOR-TO-DOOR TRANSPORTATION PROVIDED BY THE PROGRAM PARTICIPANT.";

and in line 35, strike "(H)" and substitute "(I)".

On page 4, in line 5, after "(2)" insert "<u>SUBJECT TO THE LIMITATIONS IN § 7-1002(G)</u> <u>OF THIS SUBTITLE</u>,"; strike beginning with "FOUR" in line 5 down through "EACH" in line 7; in line 8, strike "APPLICANT" and substitute "<u>APPLICANTS</u>"; in line 11, after "RECEIVING" insert "<u>GRANTS TOTALING</u>"; and in line 12, strike "ONE GRANT" and substitute "<u>\$100,000</u>".

On page 5, in line 5, strike "AND"; after line 5, insert:

"(5) THE ABILITY OF THE PROGRAM APPLICANT TO COORDINATE ITS DISPATCHER SYSTEM WITH A LOCAL CENTRAL DISPATCHER SYSTEM; AND";

in line 6, strike "(5)" and substitute "(6)"; in line 33, strike "AND"; and after line 33, insert:

"(5) IF THE PROGRAM PARTICIPANT CHARGES FEES FOR DOOR-TO-DOOR TRANSPORTATION:

(I) THE FEE SCHEDULE USED BY THE PROGRAM PARTICIPANT;

(II) <u>THE METHODOLOGY USED IN ESTABLISHING THE FEE</u> <u>SCHEDULE; AND</u>

(III) THE TOTAL AMOUNT OF FEES COLLECTED BY THE PROGRAM PARTICIPANT;

(6) <u>THE AMOUNT AND SOURCE OF ANY REVENUE, OTHER THAN FEES</u> <u>REPORTED UNDER ITEM (5) OF THIS SECTION, GENERATED BY THE PROGRAM</u> <u>PARTICIPANT IN CONNECTION WITH THE PROGRAM; AND".</u>

On page 6, in line 1, strike "(5)" and substitute "<u>(7)</u>"; and in line 2, after "PROGRAM" insert "<u>AND MONITOR THE USE OF GRANT FUNDS AWARDED TO THE PROGRAM</u> <u>PARTICIPANT</u>".
