(2) THE RESULTS OF THE CRIMINAL HISTORY RECORDS CHECK SHALL BE PROVIDED TO THE BOARD AND THE APPLICANT".

## AMENDMENT NO. 3

On page 17, after line 35 , insert:
"(7) PERFORMS THE DUTIES OF A PROGRAM ADMINISTRATOR WITH AN UNAUTHORIZED PERSON OR SUPERVISES OR AIDS AN UNAUTHORIZED PERSON IN PERFORMING THE DUTIES OF A PROGRAM ADMINISTRATOR;";
and in line 36 , strike "(7)" and substitute "(8)".

On page 20, in line 28, strike "(13)" and substitute "(63)".
